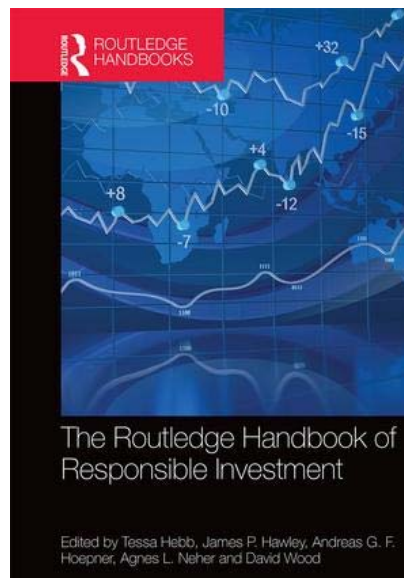
A message from Tessa Hebb:
