## **Course Description**

In this course we will study the thought of one of the medieval period's most profound and controversial figures, the famous Spanish Sufi Ibn 'Arabi (d. 1240 CE). We will first turn our attention to a detailed examination of Ibn 'Arabi's ontology and conception of imagination. This will then set the stage for a full-scale engagement with his theology, epistemology, hermeneutics, soteriology, and doctrine of human perfection. *Prerequisite*: Professor's permission.

The Associate Deans of the Faculty conduct a rigorous investigation, including an interview with the student, when an instructor suspects a piece of work has been plagiarized. Penalties are not trivial. They can include a final grade of "F" for the course
