Pammett is Professor of Political Science and Associate Dean of Research and Faculty Development, Faculty of Public Affairs and Management, Carleton University Prof. Pammett is one of Canada's premier specialists on survey research. He participated in the design of the Canadian National Election Studies of 1974, 1979 and 1980, and other surveys of more recent elections and referendums. These have resulted in numerous books and articles, including *Political Choice in Canada* and *Absent Mandate: Interpreting Change in Canadian Elections*; he is co-editor, with Chris Dornan, of *The Canadian General Election of ...* series, most recently *The Canadian General Election of 2004 (Dundurn, Toronto)*. Pammett has led Canada's participation in the International Social Survey Programme (ISSP) since 1998. He has edited, and contributed to, books using ISSP data on *Social Inequality in Canada* and *Environmental Attitudes in Canada and Around the World*. Recently, Pammett's current research on the nature of democratic participation includes a number of reports and articles for Elections Canada, including *Explaining the Turnout Decline in Canadian Federal Elections: A New Survey of Non-Voters* and *Confronting the Problem of Declining Voter Turnout Among Youth*.
