Dr. Tatjana Muravska, Short-Term Visiting Scholar at CES, March 1-22, 2016

This month, Dr. Tatjana Muravska is visiting us from the University of Latvia in Riga, Latvia. Since 2000, she has been Director of the Centre for European and Transition Studies, European Studies Masters Programme, Doctoral School for European Integration and Baltic Sea Region Studies, academic coordinator of the Jean Monnet Centre of Excellence, Jean Monnet Chair ad personam at LU, and former president of the Latvian European Community Studies Association. During her visit to Carleton, Dr. Muravska presented a lecture on the Deep and Comprehensive Free Trade Areas, and discussed the monetary integration maturity of the EU Newer Member States at the CETD Conference, "Canada and Europe: Converging or Diverging Responses to International and Domestic Challenges?"

New Documentary from Visiting Researcher Dr. Agnieszka Weinar

Europe Outside Europe tells the story of EU citizens emigrating to Canada. It is directed and produced by Dr. Weinar, supported by the Marie Curie Research grant (FP7). The leading question of the documentary is: How much Europe is there outside of the EU? It explores what it means to be an EU citizen in the context of immigration to a non-EU country, touching upon the meaning of EU citizenship outside the EU and questions of diaspora policies. The film also tackles the issues of integration in Canada and labour market strategies of the Europeans. The film builds on a year-long research and data collection by Dr. Weinar in various provinces in Canada, including over 70 in-depth interviews with EU citizens arriving after 2004. The film is now in post-production and will be screened at a special event at Carleton in May 2016.

CES Director Joan DeBardeleben, Visiting Scholar in Berlin

Joan DeBardeleben, CES Director, is a visiting scholar at the *Stiftung Wissenschaft und Politik* (German Institute for International and Security Affairs) in Berlin from January to April 2016. She is conducting research on causes of the Ukraine crisis and implications for the EU, including interviews in Germany and Poland. Her research visit is supported by a grant from the German Academic Exchange Service (DAAD). The research builds on her recent publication, "Backdrop to the Ukraine Crisis: The Revival of Normative Politics in Russia's Relations with the EU?" in Power, Politics and Confrontation in Eurasia: Foreign Policy in a Contested Area, Matthew Sussex and Roger E. Kanet, eds. (Palgrave Macmillan, 2015). She has also recently published the policy brief, "Russia's Integration Initiatives: Dilemmas for the European Union."



Achim Hurrelmann Continues to Serve as Director of EURUS and Associate Director of CES

Achim was awarded Jean Monnet Chair "Democracy in the European Union," supported by an EU grant of €50,000 between 2015 and 2018. His current research focuses on the politicization and legitimation of EU integration, as well as democracy in the EU. He has co-authored two articles in 2015: "The Politicization of European Integration: More than an Elite Affair?" Political Studies 63:1, 43-59, and "The Eurozone Crisis and Citizen Engagement in EU Affairs," West European Politics 39:1, 104-124, and co-edited The Legitimacy of Regional Integration in Europe and the Americas (Palgrave Macmillan, 2015). He remains busy with his SSHRC-funded research on "The Eurozone Financial Crisis and the Politicization of European Integration," and is co-editing an undergrad textbook, European Union Governance and Policy-Making: A Canadian Perspective.

Four of our CES Associates have written policy briefs, prepared for the Canada-Europe Transatlantic Dialogue conference "Canada and Europe: Converging or Diverging Responses to International and Domestic Challenges?" held at Carleton on March 10-11, 2016. The series seeks to spark new ways of thinking and stimulate action on pressing public policy issues. The briefs are as follows: "Russia's Integration Initiatives: Dilemmas for the European Union" by Joan DeBardeleben; "A Canadian Perspective on the Euro Area's New Financial Governance Regime" by Patrick Leblond; "The European Experience of Climate Change Policy-Making: Lessons for Canada" by Matthew Paterson; and "Balancing Citizenship Rights in an Age of Globalization" by Elke Winter.



Highlight: Siobhán Airey, Emerging Scholar

Siobhán's doctoral research examines the legal quality of the international governance framework on Official Development Assistance (ODA). In summer 2015, with the support of a graduate research grant from CES, she undertook original empirical research in Brussels, Arusha, and Dar es Salaam to further explore the dynamic between the legal, normative, and knowledge instruments used to monitor and implement EDF aid funding under the Cotonou Partnership Agreement (2000-2020). On the EU's approach to the legalisation of its external relations, her research illustrates the significance of quasi-legal governance instruments to stabilising and reconciling apparent tensions arising from conflicts between the values underpinning the EU's foreign relations approach.
