The Centre for European Studies at Carleton University (Jean Monnet Centre of Excellence, Ottawa) invites applications for a position as scholar-in-residence for a period of four months, either from September-December 2017 or from January-April 2018. The position will involve teaching a graduate level seminar on "The EU in International Affairs"; the course will be cross-listed between two graduate teaching units at the university, the Norman Paterson School of International Affairs (NPSIA) and the Institute of European, Russian, and Eurasian Studies (EURUS).

In addition to teaching, the visitor will be expected to participate in organizing a conference, planned for the spring of 2018, on "European Union Trade Policy in the 21st Century". He/she may also participate in other teaching or outreach activities at the Centre for European Studies. We will discuss a plan to maintain teaching and/or research collaboration after the visitor returns to Europe. The visitor may also have the opportunity to visit other Jean Monnet Centres of Excellence in Canada.

Applicants must hold EU citizenship and must be based at an academic institution in an EU member state. We are seeking applicants with a completed Ph.D. in a relevant field and with a record of publication, research, and teaching in the relevant field. The scholar-in-residence will receive a stipend to cover travel and accommodation expenses, as well as a fee for teaching. Applicants should include a letter of application explaining their interest in the position, a curriculum vitae, and, if possible, a copy of a recent publication relating to a topic of relevance to this competition. In addition, two letters of reference should be provided directly to us under separate cover.
