

## **Policy Workshop: The EU's External Energy Relations: Russian and Canadian Dimensions**

**Thursday, June 13, 2013, Carleton University**

### **BIOGRAPHIES OF PARTICIPANTS**

**Andrei Belyi** is Associate Professor at the Centre for EU-Russia Studies (CEURUS) at the University of Tartu since August 2012. He is also a visiting honorary lecturer at the University of Dundee (UK) and has previously worked at the Higher School of Economics in Moscow (Russia). Dr. Belyi defended his PhD on the energy security dimension in EU-Russia relations and obtained his doctorate from Free University of Brussels. His research focuses mainly on the EU's external energy policy, EU-Russia energy relations, Russia's energy policy dynamics and international energy governance, including the Energy Charter process. Among his most recent publications are a co-authored book on *Dynamics of energy governance in Europe and Russia* (Palgrave Macmillan, 2012) and an article on the EU's missed role in international governance (*Journal for European Integration*, April 2012). Dr. Belyi is also a Member of the Editorial board of the *Journal for World Energy Law and Business* (Oxford UP) as well as a co-founder of an international academic network on Political Economy of Energy in Europe and Russia. He has done consultancy work for EU institutions, Russian governmental agencies, and private firms.

**Maurizio Cellini** joined the Delegation of the European Union to Canada in September 2009 as Head of the Economic and Trade Affairs section. He joined the European Commission in the 1990s, where he has held several positions in the areas of Trade and Fishery policies. From 2006 to 2009, he served at the EU Delegation to Burkina Faso as Head of the Regional Integration, Good Governance and Cultural section. Mr. Cellini has a Master of Arts in International Relations from Johns Hopkins University, USA, as well as a Degree in Political Sciences, major in International Relations from Pisa University. He speaks Italian, French, English, Portuguese and Spanish. Born in Italy, he is married and has two children.

**Joan DeBardeleben** is Chancellor's Professor in the Institute of European, Russian, and Eurasian Studies at Carleton University and holds a Jean Monnet Chair in the EU's Eastern Neighbourhood Relations. She is Director of the Canada-Europe Transatlantic Dialogue and of Carleton University's EU Centre of Excellence, as well as President of the European Community Studies Association-Canada (ECSA-C). She has written extensively on the EU's relations with its eastern neighbours, and on topics related to federalism, environmental politics, elections, and public opinion in Eastern Europe and Russia. Her most recent edited volumes include (with Crina Viju), *Economic Crisis in Europe: What It Means for the EU and Russia* (Palgrave Macmillan, 2013); (with Achim Hurrelmann) *Transnational Europe: Promise, Paradox, Limits* (2011); *The Boundaries of EU Enlargement: Finding a Place for Neighbours* (2008); and (with Jon H. Pammett) *Activating the Citizen: Dilemmas of Participation in Europe and Canada* (2009).

**Burkard Eberlein** is Associate Professor of Public Policy at the Schulich School of Business, York University. Dr. Eberlein's fields of research are comparative public policy and international governance, with a special interest in regulatory governance, and new forms of transnational governance arrangements involving non-state and state actors. He has published widely on EU multi-level regulation and energy policy, and is the lead editor of *Governing the Energy Challenge: Canada and Germany in a Multi-Level Regional and Global Context* (University of Toronto Press, 2009, with G. Bruce Doern).

**Amelia Hadfield** is a Professor and Jean Monnet Chair in European Foreign Affairs at the Vrije Universiteit Brussel (VUB). Dr. Hadfield is also Senior Research Fellow, Head of the Educational Development Unit and Director of the MSc in European Integration at the Institute for European Studies (IES). She teaches EU Foreign Policy and Public Policy Analysis at the VUB and IES, and undertakes regular guest lectureships at universities in Europe and Russia. A Fellow of the Royal Institute for International Affairs (London) and the Centre for European Policy Studies (Brussels), Dr. Hadfield's research is focused upon energy security. While her main area of interest is EU-Russia energy relations, she also investigates EU energy relations with sub-Saharan Africa, the EU's Neighbourhood Policy relations as they operate in the Middle East, North Africa and Central and Eastern Europe, and EU-Arctic issues. Her consultancy activities include work for the UK government, the EU, and EU Member States' energy and foreign ministries.

**Nikolay Yu. Kaveshnikov** is Head of the Department of European Integration Studies at the Moscow State Institute of International Relations (MGIMO-University) and a leading research fellow at the Institute of Europe of the Russian Academy of Sciences (Moscow). He obtained his Ph.D. in Political Science in 2006 at the Institute of Europe. Since 2012, he has held a Jean Monnet Chair. Dr. Kaveshnikov's research interests include EU-Russia relations, EU energy policy, institutional development of the EU, and the EU's external relations. He currently teaches courses on EU Energy Policy, on the EU in the System of International Relations and on European Integration. Dr. Kaveshnikov is the author of more than 90 publications including articles in a wide-range of European and Russian journals. He published a book *Transformation of the Institutional Structure of the European Union* (Navona, 2010). In addition, he regularly provides expertise to the Ministry of Foreign Affairs of the Russian Federation and has participated in research and consulting projects, including for the Eurasian Development Bank, the Russian Academy of Sciences, and the European Commission.

**André Plourde** (PhD, UBC) is Professor, Department of Economics and Dean, Faculty of Public Affairs, Carleton University. Prior to that, he was on staff at the University of Alberta where he helped launch an MBA specialization in natural resources and energy. Over the years, he has twice taken leave from academic life to work in the federal public service (first with the Department of Finance and then with Natural Resources Canada). Dr. Plourde has also served on numerous advisory committees. In 2007, he was appointed to the Province of Alberta's Royalty Review Panel and was also President of the International Association for Energy Economics. More recently, he was a member of the Royal Society of Canada's expert panel on the environmental and health impacts of Canada's oil sands industry. He has published widely on energy demand analysis, Canadian energy policy, Canada-US energy relations, and on linkages between energy and environmental policy.



**Stephan Schott** is a Professor in the School of Public Policy and Administration at Carleton University with a PhD from the University of Guelph, Ontario (Canada) in Natural Resource and Environmental Economics. Dr. Schott teaches graduate courses in natural resource management, environmental and ecological economics, social benefit cost analysis, energy economics and economic theory. He is currently the coordinator for the new interdisciplinary M.A. in Sustainable Energy Policy and the concentration leader for Innovation, Science and Environment in the M.A. for Public Administration. He has published in a wide range of journals, policy outlets and special topic books, and currently focuses on energy strategies, North American carbon emission reduction programmes, air pollution models, and sustainable development in the North and behavioural experiments.

**Sergey N. Stokov** is the Agricultural Counsellor at the Embassy of the Russian Federation in Canada since 2010. He received his M.Sc. in agricultural economics from Iowa State University in 1996, and previously completed graduate and PhD courses in economics at Moscow State University. Mr. Stokov was Agricultural Counsellor at The Embassy of the Russian Federation to the U.S. from 2001 to 2007. He has worked primarily in the field of agricultural sciences and agrarian studies, in Moscow, Russia, as Senior Scientist, The Agrarian Institute; Deputy Director, All-Russian Institute for Agrarian Studies and Informatics, and at The Foundation for Support of Agrarian Reform and Rural Development; and as Scientific Consultant, The Headquarters of All-Union Academy of Agricultural Sciences. Mr. Stokov was a Visiting Scholar at Iowa State University, Center for Agricultural and Rural from 1994 to 1996.
