Precludes additional credit for <u>CLCV 2900</u> and <u>HIST 2900</u>. Prerequisite(s): second-year standing or permission of unit.

The final date for withdrawal from this course without academic penalty is **December 8, 2014.**

Research Project: This consists of a brief summary and annotated bibliography closely focused on problems and controversies in our understanding of a particular topic in Greek history. A list of topics and instructions for the Project are posted on cuLearn. You may sign up for a topic (deadline Oct.6) by emailing the professor or by signing the sheet in class.

Late policy: The Research Project must be handed in by the start of class on November 19. If it is not in my possession when I begin lecturing on that date, it will be considered <u>1 day late</u>. The penalty for late submission will be 10% subtracted from the grade for each working day late.

1 day late = minus 10% penalty; 2 days late = minus 20%; 3 days = minus 30%; 4 days = minus 40%; 5 days = minus 50%. After five days, the work will receive a mark of zero.

Tests: The midterm test and final exam will include various types of questions (short answer, essay, and commentary). The midterm test will cover all material covered in lectures and all assigned readings – up to the date of the test. The final exam will cover all material since the midterm test: students will not be asked questions specifically on material from before the midterm test, but are encouraged to incorporate information from earlier lectures into responses on the exam.

Make-up tests will only be given for valid, documented reasons. The professor must be informed of such cases *immediately*. Make-up tests are normally written within one week of the original test and at the convenience of the professor.

Academic offences: All students are expected to know what constitutes an academic offence, to avoid committing academic offences, and to take responsibility for their academic actions. Academic offenses include things like plagiarism, cheating, improper research, obstructing academic activity, double

submission, unauthorized collaboration, impersonation, falsification etc. When an offence is committed, penalties will be imposed by the Associate Dean in accordance with the regulations of the Faculty of Arts and Social Sciences.

A <u>normal</u> penalty for a first offence is a <u>mark of zero</u> for the work affected. Stiffer penalties may be imposed, and are normal for repeat offenders.

COPIES OF WRITTEN WORK SUBMITTED

Always retain for yourself a copy of all essays, term papers, written assignments or take-home tests submitted in your courses.

PLAGIARISM

The University Senate defines plagiarism as "presenting, whether intentional or not, the ideas, expression of ideas or work of others as one's own." This can include:

- reproducing or paraphrasing portions of someone else's published or unpublished material, regardless of the source, and presenting these as one's own without proper citation or reference to the original source;
- submitting a take-home examination, essay, laboratory report or other assignment written, in whole or in part, by someone else;
- using ideas or direct, verbatim quotations, or paraphrased material, concepts, or ideas without appropriate acknowledgment in any academic assignment;
- using another's data or research findings;
- failing to acknowledge sources through the use of proper citations when using another's works and/or failing to use quotation marks;
- handing in "substantially the same piece of work for academic credit more than once without prior written permission of the course instructor in which the submission occurs."

Plagiarism is a serious offence which cannot be resolved directly with the course's instructor. The Associate Deans of the Faculty conduct a rigorous investigation, including an interview with the student, when an instructor suspects a piece of work has been plagiarized. Penalties are not trivial. They can include a final grade of "F" for the course
