## **COURSE DESCRIPTION**

This course examines some of the ways in which law regulates relationships among legal persons. We will look at the manner in which rights are created and enforced through such mechanisms as property rules, contractual agreement and liability rules. The manner in which legal categories and concepts embody particular visions of social life will be emphasized. The course will also emphasize the role played by the state in the ordering of private law relations. You should learn about how private law works, the impacts of private law and why particular rules exist.

#### NOTES ON ACCOMMODATION:

For Students With Disabilities: Students with disabilities needing academic accommodations in this course must contact a co-ordinator at the Paul Menton Centre for Students with Disabilities to complete the necessary *letters of accommodation*.
