### <u>GENERAL</u>

The purpose of this course is to provide a broad introduction to the Canadian criminal legal system. The course will examine the basic framework of criminal law, its sources and the institutions, procedures, rules and actors that comprise the system. The goal is to achieve an understanding of how the criminal law operates in the context of Canadian society and to appreciate its features. The course will also cover some of the substantive and topical areas of criminal law to provide the necessary understanding of how the foregoing aspects interrelate and interphase.

**N.B.** The prerequisite for enroling in this course is the successful completion of LAWS 1000.

Pre-trial to trial Plea bargaining Sentencing and Punishment
