COURSE DESCRIPTION

This course examines the international regime for the regulation of international trade and investment. Its primary focus is on the legal obligations arising under the World Trade Organization (WTO) and the North American Free Trade Agreement (NAFTA), but other relevant regional and bilateral trade and investment agreements will also be discussed. The course considers the legal and political mechanisms that create and give effect to these obligations, as well as those for resolving trade and investment disputes between nations.
