COURSE DESCRIPTION

The aim of the course is to develop a critical understanding of the relationship between drugs and criminal law in Canada. We will examine various topics involving drug use and trade and how that defines our approach in regulating substances and dealing with related criminal activities.

We will focus on the issues of prohibition and decriminalization and whether either approach works better in decreasing usage and addiction rates (and other related criminal activities). The course will focus on drug policy in Canada but will use international studies and examples to explore what approach, if any, deals best with the various issues surrounding drug production, use and abuse.
