COURSE DESCRIPTION:

This course will engage an analysis of issues in restorative justice including the impacts of these processes for victims, offenders and communities; the role of apology and the question of forgiveness; accountability and evaluation of restorative processes; and the potential for restorative processes to realize promises of social transformation. We will be discussing such restorative processes as conferencing, sentencing circles, peacemaking in the realm of criminal justice, and the use of restorative processes in responding to gross human rights violations.

EVALUATION PROCEDURES:

Class Participation 40% This course will centre upon debates and discussions of the

weekly topic; students will be assessed in terms of both quality and quantity of participation, and should note that no more than 10% of this portion of the course assessment will be awarded

for attendance.

Class Presentation 30% Starting in Week 3 students will present in groups of 2-3

(depending upon enrolment) on an issue of their choice relevant to the subject matter of the course. It is expected that presentations will be thoroughly-researched, critically-informed,

and no less than 20 minutes in length.

Issues Paper 30%

Students will be required to compile a research essay of no less than 15 pages, on an issue relevant to the subject-matter of the course and informed by a reference list of no less than 10 sources, of which no more than 3 may be internet-based.

Papers will be Due Monday June 29, by 4:30 p.m.; submission of papers is via the Law Department Assignment Drop Chute, C473 Loeb Building. Papers which are not submitted in this manner, and which are not date-stamped by the Law Office, will not be accepted. Late papers will be subject to a penalty of 5% per day.
