COURSE DESCRIPTION

As a field of study moral psychology is *interdisciplinary*, in that it brings together philosophers, psychologists, cognitive scientists, and others interested in studying how morality works from both theoretical and empirical perspectives. Indeed, moral psychology in its current form is a blend of philosophical theory, and empirical research: philosophical theory is applied to inform, interpret and question empirical findings, while empirical findings are applied to test various theoretical commitments. This course introduces students to a range of current topics in moral philosophy and psychology, such as: normative theories, motivation, altruism, moral emotions, rules, moral reasoning, intuitions, and responsibility. Some of the questions that will be considered include: What is a moral judgment? What role do emotions play in morality? What motivates our moral

actions? What role do rules play in our moral judgments? Is there such a thing as moral character?

PEDAGOGY

As much as possible, I will be planning classes using a "flipped class" approach in which students support each other in learning activities. In addition, some required material might be delivered via online mini-lectures. Information about online lectures will be available on cuLearn. This means that I will minimize traditional lecturing in favour of a supported, individual and peer learning environment.

To support a peer-learning environment it is my expectation that you arrive to class prepared, having read the required readings, and completed any assigned online activities. Material that is introduced in class, and/or on class slides, will be fair game on all assignments and exams. It is in your best interest to attend all classes and participate as much as possible. You should arrange to get notes from a friend/colleague if you are unable to attend class in person. My hope is that you come away from this course with an appreciation for the topics, and a genuine interest in pursuing further studies in philosophy.
