**Course description:**

European philosophy of the 18<sup>th</sup> century. Representative works of writers such as Berkeley, Hume, and Kant.

Prerequisite: 0.5 credit in philosophy and second-year standing in a philosophy program, or permission of the department.

**Required text (available at the Carleton bookstore):**

1. *Modern Philosophy: An Anthology of Primary Sources*. Eds. Roger Ariew and Eric Watkins. Hackett 2010.

Note: Many of the primary sources in this anthology can be found online. However, some online sources are abridged or otherwise altered. If you wish to consult an online source, you *must* discuss this with me, so I can help you evaluate whether or not the source is appropriate.

Course material may sometimes include some readings that are not in the required text. Those readings will either be available on cuLearn or through the Carleton library website.

**cuLearn:**

Please note that this course will be supported by the cuLearn Course Management System. A variety of resources may be made available through the cuLearn site, including some readings for the course. **Evaluation:**

1. Tests – There will be two in-class closed-book mid-term tests, each worth **25%** of your final grade. You will be permitted to bring a one-page, double-sided “cheat sheet” to each test, upon which you may write whatever you like.

2. Examination – There will be one take-home examination, due at the end of final exam period (**April 26<sup>th</sup>, 2014.**) The exam will be essay-based and will count towards **50%** of your final grade.

**Course policies:**

1. Lateness/extensions – The take-home exam is due on the final day of exam period. It is university policy that no student work may be accepted after the final day of exam period. *As such, I will not be accepting late papers, and no extensions will be granted.*

### Assignments:

Unless specifically told otherwise by their instructors, students:

- The Philosophy Department does not accept assignments by FAX. You may send them by courier, if necessary.
- No assignments will be accepted after the last day for handing in term work – see dates in next column.
- Assignments handed in through the essay box (just inside the glass doors, Paterson Hall, Floor 3A) must be dropped into the box by **4:15** on a regular business day in order to be date-stamped with that day's date. Assignments handed in after 4:15 or on a non-business day will be stamped as having been handed in on the next business day.
- Students are required to keep copies of their assignments. If your paper is lost at any point, you will be considered not to have submitted it if you cannot produce a copy immediately on request.

### Deferrals for Term Work:

If you miss a final examination and/or fail to submit a final assignment by the due date because of circumstances beyond your control, you may apply for a deferral of examination/assignment. For deferred examinations, you must apply within 5 working days after the scheduled date of your exam.
