Course Description

This course is a survey of modern and contemporary political ideologies. Beginning with classical conservatism and liberalism, we will progress through the 20th century and engage with intellectual and political movements including Marxism, social democracy, Fascism, and end with contemporary ideas related to globalisation and neoliberalism. The objective of the course is to foster for the students a working knowledge of the main tenets of these ideologies and a basic understanding of their historical importance. It is important to note that the class focuses primarily on the *ideas* that constitute these ideologies and less on how they have manifested themselves in empirical/historical events. As part of the ARTS ONE Human Rights Cluster, there will be a special focus on how the various ideologies relate to human rights.

* **Please Note:** For writing assignments, students will be evaluated primarily in terms of: 1. coherence, depth, and accuracy of argument, 2. inclusion of required number of legitimate secondary sources; 3. grammar, style, and structure; and 4. quality of thesis statement.

Examinations

There will be one (final) exam (40% of final grade). The format of the exam will be a mixture of multiple choice, short answer, and long answer.

Term Work

Course Papers:

Students will write two short (5-6 page) papers (12 font, Times New Roman, double-spaced). A minimum of **5 legitimate secondary sources** are required, three which must come from *recognised scholarly journals or books*. A list of topics will be distributed that students must choose from. The first paper is due on October 7 and the second on November 18. All papers must be submitted to the instructor **in-class** on the assigned dates. Papers will be handed back to students *in their discussion groups*. If a student can not be present at the discussion group, they can leave a self-addressed stamped envelope with the instructor when they are submitting their paper. The instructor will then mail the graded paper to the student.

Late Assignment Policy

Any paper that is handed in after the class is finished on the assigned date will be considered late. All papers handed in late will receive a deduction of 1/3 of a full letter grade per day late. So, for example, a paper that receives an A grade but is a day late, will be recorded as an A-. If the same paper is two days late, than the mark assigned will be B+, etc. There will be no exceptions to this rule (except in case of documented emergencies). Late papers can be left in the department of Political Science drop box (B 640 Loeb Building). The drop box is emptied every weekday at 4:00 PM and time-stamped. Any papers dropped off after 4:00 PM will be considered submitted the following day.

Other forms of evaluation

Participation

5% of the final grade will be determined by the student's contribution to his or her discussion group. Discussion group leaders will describe the criteria for calculating the participation grade.

Attendance

5% of the final grade for the Fall term will be based on attendance at the discussion groups. Students will be allowed to miss one discussion groups without penalty. All subsequent absences will result in a 1% penalty per absence (as a percentage of the final course grade). Therefore, if the student misses 6 or more discussion groups, they will receive no attendance marks.

Academic Accommodations

For students with Disabilities: Students with disabilities requiring academic accommodations in this course must register with the Paul Menton Centre for Students with Disabilities (500 University Centre) for a formal evaluation of disability-related needs. Plagiarism: The University Senate defines plagiarism as “presenting, whether intentional or not, the ideas, expression of ideas or work of others as one’s own.” This can include:

- reproducing or paraphrasing portions of someone else’s published or unpublished material, regardless of the source, and presenting these as one’s own without proper citation or reference to the original source;
- submitting a take-home examination, essay, laboratory report or other assignment written, in whole or in part, by someone else;
- using ideas or direct, verbatim quotations, or paraphrased material, concepts, or ideas without appropriate acknowledgment in any academic assignment;
- using another’s data or research findings;
- failing to acknowledge sources through the use of proper citations when using another’s works and/or failing to use quotation marks;
- handing in "substantially the same piece of work for academic credit more than once without prior written permission of the course instructor in which the submission occurs.

Plagiarism is a serious offence which cannot be resolved directly with the course’s instructor. The Associate Deans of the Faculty conduct a rigorous investigation, including an interview with the student, when an instructor suspects a piece of work has been plagiarized. Penalties are not trivial. They include a mark of zero for the plagiarized work or a final grade of "F" for the course.

Oral Examination: At the discretion of the instructor, students may be required to pass a brief oral examination on research papers and essays.

Submission and Return of Term Work: Papers must be handed directly to the instructor and will not be date-stamped in the departmental office. Late assignments may be submitted to the drop box in the corridor outside B640 Loeb. Assignments will be retrieved every business day at **4 p.m.**, stamped with that day's date, and then distributed to the instructor. For essays not returned in class please attach a **stamped, self-addressed envelope** if you wish to have your assignment returned by mail. Please note that assignments sent via fax or email will not be accepted. Final exams are intended solely for the purpose of evaluation and will not be returned.

Grading: Assignments and exams will be graded with a percentage grade. To convert this to a letter grade or to the university 12-point system, please refer to the following table.

Approval of final grades: Standing in a course is determined by the course instructor subject to the approval of the Faculty Dean. This means that grades submitted by an instructor may be subject to revision. No grades are final until they have been approved by the Dean.

Course Requirements: Failure to write the final exam will result in a grade of ABS. FND (Failure No Deferred) is assigned when a student's performance is so poor during the term that they cannot pass the course even with 100% on the final examination. In such cases, instructors may use this notation on the Final Grade Report to indicate that a student has already failed the course due to inadequate term work and should not be permitted access to a deferral of the examination. Deferred final exams are available ONLY if the student is in good standing in the course.
