COURSE DESCRIPTION

This course provides a general overview of the historical origins and development of Buddhist doctrine and practice. Through lectures and audio-visual materials students will be introduced to Buddhist beliefs, rituals, methods of meditation, and symbolism. The implications of the geographical expansion of Buddhism throughout Asia and into the west will also be a component of this introduction.

Course Aims/Learning Outcomes

- 1. Knowledge of the Buddha and his life and teachings in their historical context.
- 2. Familiarity with the main phases and developments in Buddhist doctrine and practice, and an understanding of the differences between the major schools.
- 3. Awareness of the history of Buddhism and the main social, cultural, and intellectual developments.
- 4. An appreciation of the geographical spread of Buddhism and how Buddhist ideas influenced, and were influenced by the cultures it encountered.

Special Pedagogical Features

The course is taught through the medium of an online textbook which links directly to carefully selected sites on the internet, thereby enhancing the learning experience by providing access to a range of multimedia resources.

PLAGIARISM

The University Senate defines plagiarism as "presenting, whether intentional or not, the ideas, expression of ideas or work of others as one's own." This can include:

- reproducing or paraphrasing portions of someone else's published or unpublished material, regardless of the source, and presenting these as one's own without proper citation or reference to the original source;
- submitting a take-home examination, essay, laboratory report or other assignment written, in whole or in part, by someone else;
- using ideas or direct, verbatim quotations, or paraphrased material, concepts, or ideas without appropriate acknowledgment in any academic assignment;
- using another's data or research findings;
- failing to acknowledge sources through the use of proper citations when using another's works and/or failing to use quotation marks;
- handing in "substantially the same piece of work for academic credit more than once without prior written permission of the course instructor in which the submission occurs."

Plagiarism is a serious offence which cannot be resolved directly with the course's instructor. The Associate Deans of the Faculty conduct a rigorous investigation, including an interview with the student, when an instructor suspects a piece of work has been plagiarized. Penalties are not trivial. They can include a final grade of "F" for the course
