# **Open Session:**

## 1) Welcome

The Chair welcomed everyone to the Open Session of Senate.

## 2) Approval of Agenda

It was **MOVED** (R. Hoey, H. Logan) that Senate approve the agenda of February 26, 2016. It was **PASSED UNANIMOUSLY**.

## 3) Minutes:

a) January 29, 2016

It was **MOVED** (W. Jones, R. Hoey) that Senate approve the minutes of the open session from the meeting of January 29, 2016. It was **PASSED**.

# 4) Chair's Remarks:

The Chair stated that Carleton's 2015 Service Excellence Awards had recently been awarded. The Chair recognized the 149 nominations that were received, the supportive colleagues that nominated them and congratulated the award recipients.

The Chair also reported that the new provincial budget included funding changes designed to help students from low-income families attend university. (The Chair indicated to Senate that a more detailed report on the budget would be included with the Senate minutes - see the Appendix).

# 5) Senate Administration:

a) Convocation Dates

The Clerk provided an update to the proposed Convocation dates that were circulated with the meeting materials. The dates proposed, as updated, are:

b) Tenure and Promotion Appeals Committee Membership (for information) The Clerk reported that the vacancy on the Committee for a second Science representative had been filled by Prof. G. Dix.

The Clerk stated that information regarding upcoming Senate elections will be circulated prior to the next Senate meeting. The Clerk reminded Senators of the requirement that Senators who are on leave (sabbatical or other) are not permitted to remain on Senate but may stand for election to Senate on return from their leave.

# 6) Discussion Period: 2016 Budget Process (D. Watt)

The Chair stated that this is D. Watt's last budget presentation to Senate, as he will be retiring shortly. D. Watt made a presentation on the University's current financial situation, answered questions from Senators and led a discussion on the possible changes to the provincial funding framework. Once approved by the Board, Senate will be given a detailed breakdown of tuition fees.

7) Ratification of Carleton University Committee on Quality Assurance Membership (J. Shepherd)

J. Shepherd reported that this committee has two new members: A. Ramirez and C. Bennell. There remains one vacancy for Engineering and Design.

It was **MOVED** (J. Shepherd, J. Tomberlin) that Senate ratify the 2016-17 membership of the Carleton University Committee on Quality Assurance.

It was **PASSED UNANIMOUSLY**.
