1. Question Period

1.1 Banner Update

In response to a question from Ms J. Breakspear on the status of the Banner system, dated 28 May 2002 (Appendix A), Dean L. Librande stated that we are currently in a period of assessing our progress and how well we will do in the future. He added that assessment will continue into the Spring of 2003. He noted that web registration is not going to occur for this Fall and therefore Touchtone registration will be used one more time.

2. Touchtone Course Numbers

In response to a question from Ms Breakspear on the above-noted matter, Prof. Mortimer stated that both the old and new course numbers are being provided in the RICS, but Touchtone will use the old numbering system.

3. Availability of the Calendar for 2002-03

In response to another question from Ms Breakspear on the above-noted matter (see Appendix A), Prof. Mortimer noted that there will be three versions of the Calendar—paper, web and CD; the printed Calendar is at the press now and will be available before the end of June, the web version is almost ready, and the RICS booklet by 9 July.

4. Student Code of Conduct

In response to a question on the above-noted matter (see Appendix A), Dr. G.S. Adam stated that the University has studied some Codes from other universities, and is considering one for Carleton. Dean Librande noted that some of the elements already exist in the Calendar. He pointed to the Human Rights document and items on discrimination and harassment. All groups on campus will be asked to comment on the Code of Conduct.

Dr. Adam commented that Carleton's retention rates are low.

Prof. Mortimer noted that the Senate Committee on Admissions and Studies Policy would have the responsibility of monitoring the effects of the new rules.

With regard to Recommendation #1 (Appendix E, p. 2), Dr. Adam stated that we do receive BIU's for Summer School. Prof. J.C. Armitage commented that Carleton was always above the corridor, adding that it is not clear now much funding will be brought into Carleton with the new formula. It was agreed to change the recommendation to state that Summer School, in order to be viable, should be self-funding, and it was AGREED to receive this as the Recommendation.

It was MOVED (Mills, Armitage)

that Senate approve Motion #4, as outlined in the Report (Appendix E, p. 2).

With regard to the impact of first year seminars, Dr. Adam stated that the Retention Report attributes that it is higher because of these courses.

On the matter of the high school curriculum, Ms S. Gottheil, Associate Vice-President (Enrolment Management), commented that the perception is that students are not doing as well in high school under the new curriculum, especially in Mathematics. She noted that the Ministry is conducting a study of the two grade 11 cohorts which indicates that the marks between the two cohorts are comparable.
