#### 1. Question Period

#### 1. Policies for Displays on Campus

In response to a question from Prof. R. Thomas on the above-noted matter (Appendix A), Dean L. Librande stated that this is a

difficult issue, and the particular display in question was in Baker Lounge in the Unicentre, which fall under the purview of CUSA, who have rules on the need to book space and time, and what is expected. He noted that the material in question was not properly documented, but this was eventually taken care of. He noted that the University generally has concern for security and safety; posters were not approved and most were taken down. It is a matter that concerns the University but the focus was on safety and security. Mr. J. Bright, President of CUSA, commented that there is a protocol and set of rules and policies for Baker Lounge, and that these will continue to be monitored.

#### 2. Ph.D. Tuition Waived at UBC

Prof. V. Kumar commented on an article in the *National Post* on the above-noted matter (Appendix B). He asked about the funding at Carleton for graduate students, claiming that this has never been a priority issue for the past six or seven years. He expressed concern about graduate and doctoral programs at Carleton, and asked if the University is considering any further help in this regard.

Dr. G.S. Adam, Acting Chair, noted that the issue is the level of support and not tuition, and we have increased the level of scholarships to top up assistantships. Dean Blockley noted that tuition waivers are in fact scholarships in many universities.

#### 3. Undergraduate Teaching Assistants

In response to a question from Ms. A. Rounce on the above-noted matter, Dr. Adam stated that there will be a very substantial spike in first year enrolment as a result of the double cohort, with an anticipated increase of 1,100 in first year. In four years time we will be back down again to 4,700 first year students. Undergraduate teaching assistant growth will partly be reflected in the growth of the undergraduate student population, adding that money has been allocated to the Deans to support seniors and undergraduate teaching assistants. Dean Blockely noted that he is in a position to convert some of the undergraduate TA's to graduate TA's.

#### 4. International Student Tuition Fee Increase

Ms. A. Rounce queried the 16.8% tuition fee increase for international students in Engineering. Dean Blockley stated that he is less concerned about the fee than he is about support for these students.
