- 1. Chair's Remarks

The President, as Chair, made the following remarks:

1.1 Rae Commission Report

The President reported that the above-noted Report is now contained on the web. He noted that the recommendations contained in the Report are consistent with those put forward by the Council of Ontario Universities, adding that now the environment for the preparation of the provincial budget is very good. He noted that the first recommendation calls for new legislation that governs post-secondary education, and COU is not in favour of the proposed new Council that will monitor and examine the agreements between the Ministry of Training, Colleges and Universities and universities.

He noted that tuition fees and student aid go hand in hand, and this would have to be in place before fees can be deregulated.

- 3.1 Report re Student Attitudes toward Registration 2004

In connection with the Senate minutes of 28 January, p. 4783, item #13, Ms A. Tierney, Dean of Student Affairs, reported that the figure of 3,000 advising appointments pertained only to first year students, adding that, in total, there were over 8,000 appointments made last year.

3.2 Approval of a First Year Seminar Course, Faculty of Arts and Social Sciences

The Clerk reported that he, on behalf of the Senate Executive, approved a new First Year Seminar course, FYSM 1609 (Appendix A).

3.3 Grade Review for Oral Presentations

In connection with the Senate minutes of 28 January, p. 4777, item #2.2, Mr. M. Brown questioned whether the above-noted matter had been discussed by the Academic and Research Committee. The President stated that this had not yet been discussed by the Committee, but would be in the near future, and he agreed to report back to Senate on the matter at its meeting at the end of April.

Ms S. Gottheil, Associate Vice-President (Enrolment Management), noted that there are more than 250 recruitment publications where the cut-offs are published, as well as on the University's website.

Prof. R. Laird questioned the need to publish this being as students apply to a program, not a university, adding that the appropriate place for admission standards is in the programs themselves. Prof. D. Long commented that this merely states the minimum in order for potential students to be considered, and therefore it is important information.

As a result of some discussion, it was agreed that Associate Vice-President (Enrolment Management) would make some editorial changes to the Calendar language.
