Scientific Research and Uncertainty

- Continuum from complete uncertainty to complete certainty
- Goal is to reduce uncertainty, but even in the best studies some uncertainty remains




4 Main Types of Validity (Shadish et al., 2002)

- Internal validity
 - Causal relationship between the variables
- Construct validity
 - Representation of the presumed constructs
- External validity
 - Generalizability of the results
- Statistical conclusion validity
 - Accuracy of the results




Cannot Rule Out Every Threat to Validity

- Typically a trade-off between different types of validity in any one study



Some Strategies for Reducing Uncertainty


- Methodologically rigorous studies minimize the number and plausibility of threats to validity, thereby permitting stronger inferences



Some Strategies for Reducing Uncertainty

- More rigorous research designs
- Measurement and statistical control of confounding variables
- Better measures
- More representative sampling of population
- Larger samples
- Synthesize evidence from studies with complementary strengths and weaknesses

Acknowledging Uncertainty

- Research is the best way to reduce the degree of uncertainty about the causes of sexual offending, but cannot completely eliminate uncertainty
- Acknowledgement of uncertainty is **not** a proscription against taking action in practice or policy

Action in the Face of Uncertainty

- Speculate as needed about the causes of sexual offending
- But acknowledge the degree of uncertainty, and the distinction between evidence versus hypothesis/speculation
