

Douglas Arthur de Pencier Leadership Bursary Application

Awarded to students entering Carleton University from a high school in North Grenville, North Dundas, Winchester, Kemptville, Richmond, Osgoode, Merrickville-Wolford, Smiths Falls and North Gower areas of Eastern Ontario who require financial assistance in order to enroll full time in any undergraduate degree program. Eligible students will demonstrate academic promise, and participation in extra-curricular secondary school activities or community service. This award may be continued for 3 years of full-time enrolment provided the student maintains a GPA of 5.0 or better and continues to demonstrate financial need. Endowed in 2018 through the generosity of the Estate of Joan M. De Pencier. Up to eight students will be selected.

This award is valued at \$6000 for the 2022-23 academic year.

General Eligibility Criteria

- Canadian citizen, permanent resident or protected person
- First year full-time undergraduate study at Carleton University in any degree program
- Must demonstrate financial need
- Pursuing post-secondary studies for the first time
- Demonstrated academic promise and participation in extra-curricular activities and secondary school activities, community service or volunteer work
- This bursary is renewable over the first four years of undergraduate study provided the recipient maintains full-time enrollment in an undergraduate degree program, remains in good academic standing (minimum GPA of 5.0) and continues to demonstrate financial need
- If the bursary is lost in one year, it cannot be regained in a subsequent year
