



INTERNATIONAL WORK PLACEMENT

GINs 3900 (0.5 CREDITS), GINs 3901 (1.0 CREDIT)

A placement is a for-credit work option, which is normally unpaid. Placements must be global and international. Normally this means the placement is with an organization outside of Canada, but it could also mean work with an organization based in Canada that works on global and international issues. Students have applied their academics to real world experiences and professional opportunities in various countries including Indonesia, South Korea, Uganda, London, Peru, the United States, Canada and many more. Typically, these placements take place during the Summer term although it may be possible to do a placement in the Fall or Winter terms.

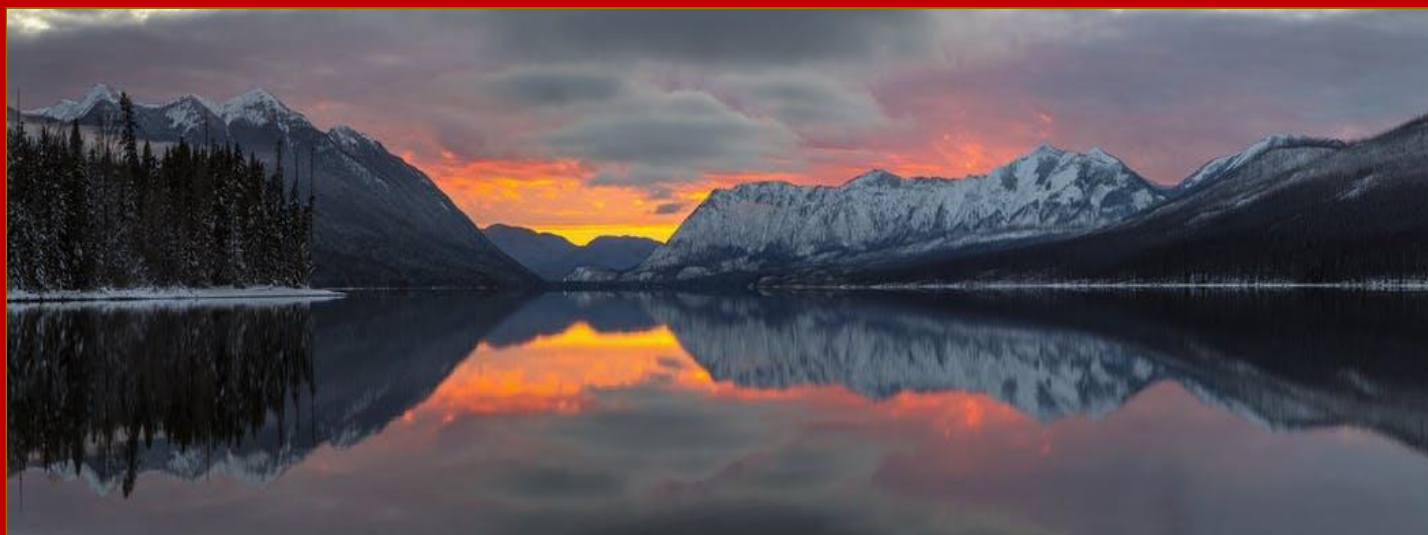

Deadlines for Summer 2018 Placements:

- Apply to the International Work Placement option by October 13, 2017
- Apply to your specific placement opportunities of interest by December 1, 2017
- All placements should be secured by January 31, 2018
- Register for GINS 3900 or 3901 by the Summer course registration deadline in March.
N.B.: GINS 3900 is a 6 week placement (0.5 credits) and GINS 3901 is a 12 week placement (1.0 credit)
- Submit all your forms on the travel registry, coordinate your flights, accommodations and travel details by March 30, 2018
