

## Bachelor of Humanities Language Course Exemption Form

The Humanities Language Requirement can be satisfied in one of two ways:

- 1) by successfully completing designated language courses ([link to list on website](#)) **or**
- 2) by demonstrating prior language proficiency in a language other than English. This form is to be used by students who wish to be exempted from taking language courses on the basis that they have prior proficiency. Please note that each individual application for an exemption from taking language courses will be treated on its merits. Listed below are general guidelines that apply to the most common cases.

Language proficiency can normally be demonstrated in one of the following ways:

1. **Secondary school language of instruction:** Students whose secondary school transcripts show that their primary language of instruction in secondary school was a language other than English may be exempted from having to take language courses.
2. **French immersion:** Students who have successfully completed Grade 12 French immersion or the equivalent at a Canadian high school may be exempted from the language requirement.
3. **Proficient Speakers:** Students who do not qualify under either of the first two categories, but who nonetheless consider themselves proficient speakers of a language other than English, may be exempted from having to take language courses. For languages taught at Carleton, “proficiency” means a level of at least equivalent to completion of one of the designated language courses linked above. For languages not taught at Carleton, “proficiency” means a level at least equivalent to two full years of university level language study. Proficiency may be demonstrated either through documentation (e.g. certification from a recognized language testing authority) or through testing.

If you wish to apply for an exemption from taking language courses, please print this form, fill in your name and student number, check one of the boxes and attach the required documentation.

**Secondary School language of instruction:** High school certificate required.

**Proficient French Speaker:** Certificate from the Department of French, or equivalent, is required.

**Proficient speaker of a language other than French which is taught at Carleton:** Certificate from the School of Linguistics and Language Studies, or equivalent, is required.

**Proficient speaker of a language not taught at Carleton:** Documentation supporting your claim is required. Testing in this language depends on faculty resource availability and will be arranged by the Program Director.
