

## **Biographies**

**Mark Camilleri** is a Canadian and EU national and qualified lawyer with two decades of professional experience helping clients with cross-Atlantic trade and investment. He is the co-founder of the Canada EU Trade and Investment Association (or CEUTIA), a Brussels based not-for-profit organization aimed at the promotion and implementation of CETA and promoting Canada-EU regulatory cooperation though dialogue and information exchanges with CETA stakeholders. Mark started his legal career as a student and lawyer in the Toronto office of the law firm Fasken Martineau before moving to its London office in 2006. In 2013, Mark moved to Brussels and started his own law firm, Camilleri Law, a Canada-EU regulatory and advisory law firm. He is a fully qualified lawyer in Ontario, England & Wales and Belgium. Mark holds a B.A. in International Relations (University of Toronto, Toronto), an LL.B./MBA (Dalhousie University, Halifax) and an LL.M. in EU Law (KU Leuven, Leuven). Mark is also a Certified Information Privacy Professional/Europe and a member of the International Association of Privacy Professionals. Mark is a part-time lecturer at the Faculty of Law, KU Leuven and teaches a course on "CETA and the Practice of Law in Brussels".
