COURSE DESCRIPTION

In this course, we will explore the nature of religious experience and the ways in which such experiences are interpreted. Our study begins with a review of various definitions of religion in order to better understand what could be meant by “religious” experience. In examining the experiential aspect of religion, a large part of this course will concentrate on the non-literate mode of religious expression that scholars categorize as ‘primal’ or shamanic. Students will then discuss readings that represent the soteriological (salvation-oriented) world-views found in the major world religions as well as readings on the nature of mysticism. Finally, in Hesse’s novel *Siddhartha* we will explore themes relating to shamanic world-views, belief in individual salvation, and mystic experience. Video and audio material will form part of the course content and students will have an opportunity to do some personal exploration of meditative states for themselves.

PLAGIARISM

The University Senate defines plagiarism as “*presenting, whether intentional or not, the ideas, expression of ideas or work of others as one’s own.*” This can include:

- reproducing or paraphrasing portions of someone else’s published or unpublished material, regardless of the source, and presenting these as one’s own without proper citation or reference to the original source;
- submitting a take-home examination, essay, laboratory report or other assignment written, in whole or in part, by someone else;
- using ideas or direct, verbatim quotations, or paraphrased material, concepts, or ideas without appropriate acknowledgment in any academic assignment;
- using another’s data or research findings;
- failing to acknowledge sources through the use of proper citations when using another’s works and/or failing to use quotation marks;
- handing in “*substantially the same piece of work for academic credit more than once without prior written permission of the course instructor in which the submission occurs.*”

Plagiarism is a serious offence which cannot be resolved directly with the course’s instructor. The Associate Deans of the Faculty conduct a rigorous investigation, including an interview with the student, when an instructor suspects a piece of work has been plagiarized. Penalties are not trivial. They can include a final grade of “F” for the course
