This application is for faculty awards under the **Strengthening Carleton's Indo-Pacific Partnerships (SCIPP)** project, led by Carleton International and funded by the **Government of Canada**. These awards provide seed funding to develop long-term research collaborations and partnerships in the Indo-Pacific region. The amount of the award is \$10,000 CAD to support activities towards the creation of a partnership and research project.

Applicants must be full-time faculty members at the university, as well as Canadian citizens or Permanent Residents. The partner or co-investigator must be in an eligible country and must provide a letter of support for the application.

Award recipients will be selected based on alignment of the research activities with the [Strategic Objectives of Canada's Indo-Pacific Strategy](#), potential for a long-term sustained partnership, clarity and strength of the proposed project, detail and feasibility of the project plan, and GBA+ considerations (both within the proposal and for the selection committee).

Eligible Expenses: A portion of the funds should be used for the PI to travel to the partner institution for a duration that is suitable to the project. The remaining funds can be used for expenses that contribute to developing the project and advancing the partnership, including stipends to students, project materials, workshop or conference organizing, translation costs, etc. Funds cannot be transferred to a partner institution or co-investigator.
