Guidelines

The International Research Seed Grants enable researchers to create new international research partnerships. The purpose is to provide seed funding towards the development of innovative, globally focused research initiatives and lay the foundation for long-term international partnerships. Applicants must demonstrate how the award will support the development of an international collaboration funding proposal and/or joint publication within two years. Research proposals will be adjudicated by an International Research Grants Committee, chaired by the Associate Vice-President (Research and International).

Eligibility: All full-time faculty of professorial rank (Assistant, Associate, Full) are eligible. Applications from Adjunct Research Professors will be considered in exceptional cases. Each application should describe a single project. Applications that include more than one project will be returned.

Deadline: Please visit IRSG web page for the deadline. Results will be announced by the end of the fiscal year.

Funding Available: Grants shall not exceed \$10,000. In order to accommodate a larger number of projects, some of the proposals might be partially funded. Eligible expenses include travel costs for Carleton and/or international partner institutional personnel, including research, meetings, and communications costs or other costs associated with partnership development; expenses associated with the development of funding proposals in collaboration with the international partner(s). Ineligible expenses include ongoing operations, capital equipment, administration of personnel costs of existing projects or initiatives; costs for initiatives that have alternative sources of funding; teaching releases; and expenses (such as travel and administration) on behalf of other Canadian universities. Applications to fund existing projects with established international partners are ineligible.

Submission to Portal: Approval from your Department Chair/School Director and Associate Dean, Research (ADR) through the cuResearch Portal is required for your application to be considered complete. Given that the approval can take some time, please indicate your intent to submit by completing the "Approval Form" in cuResearch as soon as possible. For instructions, visit IRSG web page.

Terms: As the fund is designed to seed new initiatives, the duration of funding will be a maximum of one year (12 months from receipt of award), with a one year no cost extension. Please IRSG web page for any other restrictions. The disbursement of internal competitive research funds is subject to: i) availability of funds and ii) additional (specific programmatic) considerations listed below.

Evaluation and Assessment: Applications will be assessed based on the following evaluation criteria:

- a) Scholarly significance and potential contribution to knowledge;
- b) At least one partner (academic, not for profit, and/or private sector) from outside Canada, with an indication of what is new about the relationship;
- c) Matching funds and/or an in-kind contribution from the international partner(s);
- d) Potential to lead to an institutional partnership, including an application for funding within two years of receipt of award and a review of future sources of international research funding (please visit IRSG web page);
- e) Demonstrated potential and plan for joint publication;
- f) Capacity to sustain the initiative beyond the term of the award;
- g) Record of funded research within the last five years by the Carleton applicant; and
- h) Alignment with Carleton's International Strategic Plan and Strategic Integrated Plan.

Leaving Carleton University: If, during the period of the award, the grantee resigns from his/her current appointment with Carleton University, or takes a leave (paid or unpaid) exceeding one year, the grant will be terminated. Any unspent funds will be returned to Carleton University.

Final Research Report: All grant holders are required to submit a brief online Final Report to Carleton International within 3 months following the award close out. Report forms will be sent to grantees at the end date of the project. A CV must be uploaded separately into the cuResearch Portal, including publications and currently active research grants. Please use **Adobe Reader** when completing this form.
