



The Practical Certificate in **Failed and Fragile States Policy Analysis**

Monday June 17 and Tuesday June 18, 2013 - Carleton University, Ottawa, ON

This introductory, 2-day, training workshop has been developed for policy and risk professionals working in Government, Non-Government and Corporate institutions that are seeking to engage, deploy or embark upon business in a state or region of the world where civil-society has collapsed or is under threat from political and economic upheaval.

Failed or Fragile State intervention is a highly complex and dangerous undertaking. Effective institutional response requires considerable preparation and planning rooted in sound analysis, the ability to appreciate unique aspects of social and economic dysfunction within a wide social scope and the capacity to effectively communicate both within the intervening institution and externally with the Failed or Fragile State and related stakeholders. This workshop in "Failed and Fragile States Policy Analysis" is designed to improve analytical capacity, support the risk management process and develop diagnostic skills for understanding unique state-social relationships within Failed or Fragile States. In addition, this workshop focuses on building communication and negotiation / mediation skills that are essential to success, from the step-off point of intervention to the synchronization of on-going involvement in stabilization and reconstruction.

Who should participate? - This course is intended for policy and risk-management professionals whose institutions have a role or interest in working toward the stabilization of civil-society in a Failed or Fragile State environment. Because Policy Analysis of this type is intrinsically multidisciplinary, this workshop will be of interest to Aid and Development staff, international health and education specialists, military and police, international legal experts and industry, including participants from the mining and resource extraction sectors.

What you will learn:

1. How to define Failed and Fragile States, and identify the key drivers of failure and fragility.
2. How to identify risk factors and trends in fragile states processes.
3. How institutions conceptualize conflict and fragility into Policy Frameworks.
4. Understand the current international legal, security and aid policy frameworks.
5. Use analytical tools presently available to practitioners currently working in Failed and Fragile States environments.
6. How to formulate a *response map using Policy frameworks and Country analysis*.
7. How to report Failed and Fragile States analysis to decision-makers.
8. How to use databases, case studies and scenarios for more effective policy planning.

Featured instructors:

Dr. David Carment - has over 17 years experience in policy relevant research on fragile states, conflict prevention, mainstreaming risk analysis, training and aid allocation including the **design and delivery of multi stakeholder training programs on behalf of organizations including FEWER, CIDA, UNDP and CBSA**. He has held grants from SSHRC, CIDA, DFAIT, IDRC and a variety of international organizations including the UNDP and the UNU. His current work focuses on predictive models of state failure for DRDC - GOC and aid sequencing in fragile states. As Principal Investigator for Country Indicators for Foreign Policy he has various publications on fragile states, policy analysis, aid allocation, aid effectiveness, sequencing aid and democracy and governance. He led a CIDA funded initiative on mainstreaming research on failed and fragile states into policy making over the 2004-2008 period. He also served as part of the DAC-OECD working on group on fragile states as a member of their advisory group and with WFP in the design of their HEWS II system. Dr. Carment is Professor at the Norman Paterson School of International Affairs.



Dr. Yiagadeesen (Teddy) Samy - is a development economist with numerous publications on aid and development including a recently co-authored volume on fragile states. His expertise on Small Island Developing States, aid allocation and policy issues (debt relief for the poorest countries, foreign direct investment, trade and labor standards, aid for trade, and aid and taxation) provides the training team with a strong analytical footing. He and Carment are working on aid sequencing issues and have presented their work at CGD, WIDER and ISA.
