About the position:

The Institute of Cognitive Science invites applications from qualified candidates for a term appointment in Cognitive Science at the rank of Instructor beginning July 1, 2017 and ending June 30, 2019.

The candidate is expected to teach courses at the first, second, and third year levels in cognitive science. The courses will include the following: first-year seminar (FYSM 1607), second year introductory course (CGSC 2001), second-year course in theories and methods (CGSC 2002), and a third-year course in empirical issues in cognition (CGSC 3201). The position will involve teaching three courses in each of the Fall and Winter terms, and one course in the Spring term. In the first year of the appointment, the teaching will be FYSM 1607 (2 sections), CGSC 2001 (Fall), CGSC 2002 (Winter), CGSC 2001 (Spring). The candidate will also be involved in the activities of the Institute, specifically, contributing as a member of the undergraduate committee.

The Institute of Cognitive Science (www.carleton.ca/ics) offers programs at the Bachelors, Masters, and Ph.D. levels in Cognitive Science to approximately 400 undergraduate and 40 graduate students. Carleton is one of the few institutions in the world to offer B.Cog.Sc. and M.Cog.Sc. degrees. The Institute is a fully-independent academic unit, with dedicated faculty members. It is also supported through cross-appointments from Psychology, Linguistics, and Philosophy, and supervisory contributions from several other units, including Computer Science.

Oualifications:

The position requires a Ph.D. in Cognitive Science or a related discipline, with demonstrated teaching excellence in Cognitive Science. Experience with teaching courses of various sizes is helpful. Familiarity with using a variety of methods to address issues in cognitive science is also required. Evidence of an ability to work in an interdisciplinary, collaborative environment is important.

Applicants should include a curriculum vitae and a teaching dossier. Three referees should send letters in support of the applicant to the same address. Applications should be received by March 15, 2017.
