

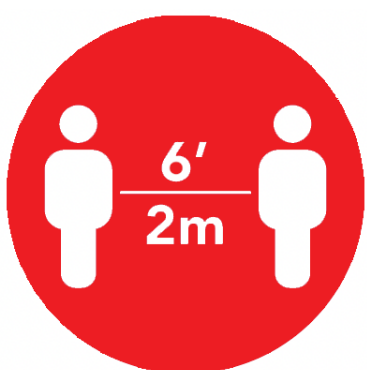
Working Together to Keep Campus Safe

Carleton's top priority is protecting the health and safety of our community. As per public health guidelines, the best ways to minimize virus transmission are through vaccination, physical distancing, mask-wearing and frequent hand washing. Before returning to campus, everyone must:

- Complete the [COVID-19: Infection Prevention and Control Training](#) on Brightspace.
 - Complete the [Vaccination Attestation Form](#) in cuScreen by early September.
 - Complete the [COVID-19 Screening Self-Assessment](#) in cuScreen. You must complete the screening self-assessment every day before coming to campus.
 - Stay home if you feel unwell and follow regular [illness/symptom reporting processes](#).

Once on campus:



- Use [cuScreen QR codes](#) to check-in to buildings, classrooms and offices for contact tracing purposes.



- Practice physical distancing. Where possible, stay two metres (six feet) apart and follow all posted signage including approved entrances and exits.



- Wear a mask as per Carleton's [COVID-19 Mask Policy](#).
 - Wash or sanitize your hands thoroughly and regularly, and avoid touching your face.
 - Employees must frequently wipe down personal workstation and shared spaces such as door handles and countertops.

Health and Safety Measures

As always, the health and safety of our campus community remains Carleton's top priority. If you're feeling unwell, you must stay home. [Report all symptoms potentially linked to COVID-19.](#)

You will notice many changes as you return to campus, such as how you enter/exit and move through buildings, and reduced occupancy limits. Please respect and follow all posted signage and directions from our cuScreen Ambassadors, who can be identified by their red t-shirts.

Facilities Management and Planning has implemented [cleaning protocols](#) in place for buildings, classrooms, common spaces, study spaces and internal department spaces. Employees are responsible for wiping down their personal workstation and should also wipe down high-touch shared equipment with disinfectant before and after use. Hand sanitizer stations are at all building entrances.

Centralized waste collection containers are in the common areas of all buildings as part of Carleton's ongoing sustainability initiatives.

Across campus, the main air handling systems in all buildings have been fitted with high efficiency (MERV 13) filters and are continuously monitored by Building Operations staff.

Until further notice, access to the tunnels is restricted to authorized individuals only and those with approval for accessibility purposes. Access requests should be directed by email to your manager, supervisor, dean or relevant approver, who will submit your tunnel access approval to covidinfo@carleton.ca.
