The Institute of Criminology & Criminal Justice at Carleton University is thrilled to invite applications from qualified candidates for a postdoctoral fellowship of 12 months, beginning as early as July 1<sup>st</sup>, 2021 and no later than September 1<sup>st</sup>, 2021.

The ICCJ postdoctoral fellow will work with an interdisciplinary team of faculty on an original research project related to, or proximate with, the research interests of ICCJ faculty. These include: abolitionism; anarchism; affect, emotion and the senses; biocriminology; critical race theory; drug policies; cultural criminology; digital technology; discrimination in the law; globalization of surveillance and security practices; Indigenous studies; juror decision-making; legal decision-making; medico-legal surveillance; moralization processes; policing; porn, media and cultural studies; queer and feminist criminologies; security governance; settler colonial studies; social control; social movements studies; social systems theory; sociology of law and punishment; surveillance of social movements; theoretical criminology; victimization; violence against women; youth and criminalization.

In addition to conducting original research in critical criminology intended for publication in high quality peer-reviewed presses, the successful candidate might have the opportunity to teach a single-term 4<sup>th</sup> year undergraduate seminar. The postdoctoral fellowship is intended to support an emerging scholar whose work makes visible and legible the limits of criminalizing and punitive logics and institutions.

### **Qualifications**

The successful candidate will have:

- A PhD either very near to completion, or completed in the past five years, in criminology or in related fields of inquiry.
- Completed the PhD prior to starting the ICCJ post-doctoral fellowship.
- A research and publication dossier appropriate to this career stage and aligned with the critical orientation of the Institute of Criminology & Criminal Justice.

**Duration:** 12 months

**Start date:** Negotiable, between July 1<sup>st</sup>, 2021 and September 1<sup>st</sup>, 2021.

**Home unit:** Institute of Criminology & Criminal Justice

**Salary:** C\$43,000 plus benefits (see PSAC local 77000 collective agreement with Carleton University)

**Research funding:** The postdoctoral fellow will have access to a research fund of up to C\$5,000.

**Relocation expenses:** Eligible moving expenses of up to C\$1,500 will be reimbursed.

**Application deadline:** March 5, 2021.

**Application process:** Applications must be sent electronically in one single PDF file which includes the following: 1) a cover letter, notably identifying the ICCJ faculty member under whose supervision the fellowship would take place, and the expected start date of the fellowship; 2) a curriculum vitae; 3) a postdoctoral research proposal (max 2,500 words, excluding bibliographic references). Interested candidates should arrange for three confidential signed and dated letters of reference to be sent in support of their application.
