
# **Academic Appointments**

It all begins with hiring the right people.

Hiring faculty, instructors and librarians is a collective responsibility. As the university's academic hiring officer, the Provost and Vice-President (Academic) collaborates with the Vice-President (Research and International), Deans and University Librarian to hire and retain the finest teachers, scholars, researchers and librarians.

# **Faculty, Instructors and Librarians**

In 2022-23, Carleton welcomed 36 new faculty, instructors and librarians (see Appendix A for a full list). Responsibilities for these academic ranks are listed below.



- Lecturers (pre-PhD), Assistant Professors, Associate Professors, Professors:
   Hired under the provisions of the Collective Agreement between Carleton University and CUASA, professors at Carleton have a responsibility to undertake teaching, research, administrative responsibilities at the University as well as to share their expertise with the wider community.
- Instructor I, Instructor III: Hired under the provisions of the Collective Agreement between Carleton University and CUASA, instructors at Carleton focus primarily on teaching or other specific designated administrative duties at the university.
- Librarian I, Librarian II, Librarian IV: Hired under the provisions of the Collective Agreement between Carleton University and CUASA, librarians at Carleton have a responsibility to provide services to library users as well as to engage in professional duties, public service, collection development, bibliographic control and technical library operations.



#### **Chancellor's Professors**

With an eye to recognizing excellence, a limited number of Full Professors are designated as Chancellor's Professors for a period of five years (renewable once). These professors have at least 10 years of service at the rank of Full Professor and are recognized for their outstanding scholarly activities and substantial international impact. Chancellor's Professors provide research leadership and actively participate in development of research at the university.

In addition to honouring individual professors, this designation increases awareness, within and outside the Carleton community, of the excellent scholarly work the university undertakes.

In 2022-23, three new Chancellor's Professors were appointed (see Appendix A for a full list). There are currently 25 Chancellor's Professors at Carleton.

## **Cross Appointments**

Cross appointments—where faculty are appointed between two or more academic units—exemplify Carleton's truly interdisciplinary nature. These appointments increase interdisciplinary collaboration in teaching and research; promote inter-faculty collaboration; and allow for the cross-fertilization and exchange of ideas.

At Carleton, 333 faculty members currently hold one or more cross appointments in another academic unit.

#### **Canada Research Chairs**

The Canada Research Chairs program is designed to attract the best talent from Canada and around the world, helping universities achieve research excellence in a wide variety of fields. Chairholders improve Canadians' depth of knowledge and quality of life, strengthen the country's international competitiveness, and help train the next generation of highly skilled people.

In 2022-23, three new Canada Research Chairholders were appointed (see Appendix A for a full list). Twenty Carleton faculty now hold Canada Research Chair appointments. More information is available on Carleton's Research website.

#### **Administrative Appointments**

Senior academic administrative appointments, including Chairs, Directors, Department Heads, Associate and Assistant Deans, and Associate and Assistant University Librarians, typically begin July 1 and are usually held for two, three or five-year terms. An acting/interim appointment may be made on a temporary basis until a full search can be held.

# **Affiliated Appointments**

# **Appointees In-Residence**

Appointees in-residence are individuals distinguished in their fields (e.g., architects, executives, public servants and writers) who use their experience and expertise to create mentorship opportunities, help with recruiting efforts, teach courses, and engage in research, support curriculum enhancement and establish linkages between Carleton and the broader community. During 2022-23, Carleton had seven in-residence appointees.

# **Visiting Appointments**

Carleton welcomes Visiting Professors and Visiting Scholars who further enrich the academic and research opportunities and experiences of students and faculty. Distinguished in their fields, Visiting Appointees bring established expertise in an area of scholarship or research relevant to Carleton's academic and research programs. In addition, Carleton participates in international agreements with France and Italy and invites language assistants who provide tutorials and other cultural activities for our students. During 2022-23, Carleton hosted 10 visiting appointees.

## **Fulbright Chairs**

As part of Carleton's Collaborate campaign in 2017, the university expanded the Fulbright program and established four new Fulbright Canada Distinguished Research Chairs in the Faculty of Arts and Social Sciences, Faculty of Public Affairs, Faculty of Science and the Sprott School of Business. This is in addition to the existing Fulbright Canada Chairs in the Department of Political Science and the Norman Paterson School of International Affairs. During 2022-23, Carleton welcomed five Fulbright Chairs.

#### Scholars at Risk

This year marks the 10<sup>th</sup> anniversary of Carleton's Scholars at Risk (SAR) initiative. This program is dedicated to protecting scholars who face threats to their lives due to their scholarship. Carleton works to protect scholars, and their ideas, and promote academic freedom by arranging one to two-year appointments in host departments across the university. SAR Carleton partners with the Scholars at Risk Network and the Institute of International Education's Scholar Rescue Fund (IIE-SRF) to arrange these annual appointments. Since the network was founded in 2000, more than 700 scholars have found sanctuary and hundreds more have benefited from SAR's advisory and referral services. Highlights from this year include:

- After a productive strategic planning session in the spring, SAR Carleton is working on developing a plan to be issued in the fall. As part of this plan, a project coordinator has been hired to focus on delivering a series of workshops in the fall related to integration and the Canadian academic context.
- In the spring of 2023, Carleton was invited to host the Royal Society of Canada's Academic
  Job Search Workshop for Displaced and At-Risk Scholars and Academics where Amber
  Lannon, University Librarian, welcomed more than 15 current and former scholars from
  across Canada and Norah Vollmer, Manager, Faculty Affairs, presented on the academic
  hiring process.
- After a successful "Free to Think Conversation" event in the spring, SAR Carleton will host an international <u>Freedom to Think Summit and Conference</u> in November featuring Nobel Peace Prize Laureate Tawakkol Abdel-Salam Karman.

Since 2015, Carleton has hosted 14 in-person at-risk scholars and coordinated remote appointments for five Global Scholars abroad. An annual report and more information is available on Carleton's






# **Honorary Ranks**

Many academics continue to be engaged with Carleton after they retire and, in some cases, an honorary or affiliated rank may be conferred upon them to acknowledge their accomplishments.

The rank of Adjunct Professor and Adjunct Research Professor (see below) is also conferred on external appointees who are experts in their respective fields across Canada and around the globe.

Depending on their rank, appointees engage with the university in various ways. This may include participating in intellectual life, such as teaching or other related projects, or participating in research, such as supervising students or applying for grants.



Currently, 1,023 individuals hold honorary ranks at Carleton. From July 1, 2022 to June 30, 2023, 170 individuals were appointed to honorary ranks.

The various honorary ranks are described below.

- **Professor Emeritus:** Professor Emeritus is automatically conferred on a professor who retires at the rank of Full Professor. This is a permanent appointment conferred by the Provost and Vice-President (Academic) that recognizes and celebrates a professor's accomplishments and contributions during their career at Carleton.
- **Distinguished Research Professor:** A Professor Emeritus who continues to be active in research work may be nominated as Distinguished Research Professor to recognize their significant ongoing research activities at Carleton.
- Adjunct Research Professor: The rank of Adjunct Research Professor may be conferred
  on a professor who retires as an Associate or Assistant Professor or an external appointee
  who is an expert in the field and engaged with a particular academic unit. This rank
  recognizes demonstrated significant scholarship and activity in research, as well as a
  continuing involvement in significant research activities at Carleton.
- Adjunct Professor: The rank of Adjunct Professor may be conferred on a professor who
  retires at the rank of Associate or Assistant Professor or an external appointee who is an
  expert in the field and engaged with a particular academic unit. This rank recognizes
  continued significant involvement in the intellectual life of the academic unit, such as
  teaching and other projects at Carleton.




# **Tenure, Confirmation and Promotion**

#### **Tenure and Confirmation**

Receiving tenure or confirmation means achieving permanent job status. Following an initial five-year preliminary appointment, faculty are typically considered for tenure, and instructors for confirmation, each fall, effective July 1. After an initial two-year preliminary appointment, librarians are typically considered for confirmation.

In 2022-23, 44 academics received tenure or confirmation (see Appendix B for a full list).



#### **Promotion**

Promotion is progression through the academic ranks. Promotions are considered each fall, and if approved, are effective the following July 1<sup>st</sup>. Faculty may be promoted through the ranks from Assistant Professor to Associate Professor, and to Full Professor. A faculty member who has not yet completed the degree that is required for a faculty appointment in their discipline is appointed as Lecturer until they obtain their degree. Instructors may be promoted through the ranks of Instructor I, Instructor II and Instructor III. Librarians may be promoted through the ranks of Librarian II, Librarian III and Librarian IV.

In 2022-23, 59 academics were promoted to the next rank (see Appendix B for a full list).




# Sabbatical and Other Leaves

Academics are eligible for sabbatical after receiving tenure or confirmation: either a six-month leave following three years of full-time on-campus service or a one-year leave following six years of full-time on-campus service.

Academic staff pursue a myriad of opportunities during sabbaticals, including researching to explore new areas or to consolidate knowledge, working on large projects, writing books and teaching at other universities.

For the period of July 1, 2022 to June 30, 2023, 125 academics were on sabbatical.
