## **Course Description and requirements**

### 1) Course description

Fundamentals: decibel, thermal noise, intermodulation, 1dB compression, dynamic range, SNR, noise figure, noise temperature, AM to PM conversion, Differential Gain and Differential Phase, antenna gain, EIRP, G/T, C/T. Line-of-sight links: frequency assignment, Earth's bulge, Fresnel clearance, free space path loss, rainfall attenuation, receiver threshold, multipath fading, diversity combining, fade margin. Fiber links: Fiber types, dispersion, loss, bandwidth-distance product, Laser Sources, fiber amplifiers PIN diode and APD detectors, Systems. Satellite links: frequency windows, GEO and LEO orbits, link calculations, illumination levels, station margin, frequency division and time division multiple accessing, earth station antennas, satellite tracking systems, Spherical Trigonometry and antenna pointing, LEO constellations.
