Innovative Program Structure

As the only North American Ph.D. program that replaces summer rote qualifier exams with augmented training in research methods, our unique structure catalyzes the transition of Ph.D. students from 'consumers' to 'producers' of research. The OCGSE Ph.D. students are supported through accelerated advisor pairings and enhanced research skills training workshops.

We have one of the largest Ph.D. programs in the country, with more than 80 domestic and international students from diverse backgrounds, who are supported by the guidance of over 50 full-time faculty members from Carleton and uOttawa Economics Departments.
