COURSE DESCRIPTION

This is the first of two introductory courses in economics (ECON 1001 and 1002). This first course focuses on microeconomics and will cover basic economics principles and applications. Some of the topics covered will include a discussion of markets, how they work and when they can fail; international trade; environmental issues and the unintended consequences of different policies, among other topics. The purpose of the course is to show students how economists think and to serve as a foundation for

further study in economics.

PREREQUISITES AND PRECLUSIONS

Precludes additional credit for ECON 1000 and FYSM 1003. A grade of C- or higher is required to qualify for ECON/MATH 1402, ECON 2009, ECON 2020, and ECON 3001. DEF(erred final grade) status at the end of this course precludes (continued) registration in any other course for which the former is a

prerequisite.

COURSE DELIVERY

Lectures, tutorials or discussion groups, and exams for this course will be in person.

REQUIRED TEXTBOOK

Mankiw, Kneebone and McKenzie (2019) *Principles of Microeconomics*, 8th Canadian Edition and the publisher's associated access to **MindTap** (an electronic platform). The corresponding Study Guide may also prove helpful but is not required.

MindTap, the textbook's associated electronic platform, will be used to complete weekly assignments that will be part of your grade. You can obtain a **12-month access to MindTap** (and to the e-book version of the textbook) for about \$75 in two ways:

- (2) Through a special link to be provided by the publisher (available on Brightspace)
- (*) Note that the University has negotiated a discounted price for Carleton students.

If you prefer to have a hard copy of the book, the University's Bookstore also offers the book with MindTap access.

Used books: A used textbook is also an option but please be aware that MindTap access is required for completion of assignments and used books might not include a valid/unused access code.

IN-CLASS PARTICIPATION

message. You will get one bonus point for participating and one for providing the correct answer. The total bonus points can add up to 5% of your final grade. Note that these are bonus points, so you can still get the maximum grade without participating in any poll. However, these are also easy points that could make up for any lost marks in guizzes or exams.

EVALUATION

Each student's grade will be calculated using the following instruments and weights:

MindTap Assignments: These are weekly electronic assignments that will allow you to practice the concepts discussed in class. Deadlines will be announced one week in advance. The assignments with the two lowest scores will be excluded from the calculation.

Quizzes: These will include short questions and will be announced at least a week in advance. Quizzes will take place during the scheduled lecture or tutorial times. If you miss a quiz for a documented compelling reason, the weight of that quiz will be reallocated to the remaining quizzes or to the final exam in the event you miss the last quiz.

Written Assignment: The deadline for the written assignment will be announced at least one week in advance. No late assignments will be accepted.

Midterms: These will take place during the lecture time.

If you miss a mid-term examination for a documented compelling reason, the weight of the midterm will be reallocated to the final exam. No makeup midterm will be offered.

Final comprehensive examination: will be formally scheduled by the University during the examination period. It will be a common exam for all ECON 1001 sections and will include all material covered in class. If you are unable to write the final exam, an application to write a deferred final examination must be made at the Registrar's Office in writing no later than three working days after the original final examination was scheduled.
