COURSE DESCRIPTION

This is the second of two introductory courses in economics (ECON 1001 and 1002). This second course focuses on basic macroeconomic principles. Some of the topics will include a discussion of how data is collected to measure macroeconomic variables such as economic output and consumption, how the economy as a whole behaves in the short and long run, the role of money and monetary policy, and the differences between open and closed economies, among other topics. The purpose of the course is to show students how economists think and to serve as a foundation for further study in economics.

LEARNING OUTCOMES

By the end of the course you should expect to:

- apply basic macroeconomic models and understand their limitations
- · understand how we measure economic activity
- · understand the drivers of economic growth
- understand the impact of government fiscal and monetary policies on economic activity

PREREQUISITES AND PRECLUSIONS

Precludes additional credit for ECON 1000 and FYSM 1003. A grade of C- or higher is required to qualify

for ECON 2102, and ECON 3001. DEF(erred final grade) status at the end of this course precludes (continued) registration in any other course for which the former is a prerequisite.

REQUIRED TEXTBOOK

Milligan, Oreopoulos, Stevenson and Wolfers (2023) *Principles of Macroeconomics*, Canadian Edition and the associated electronic platform Achieve.

Achieve, the textbook's associated electronic platform, will be used to complete weekly assignments that will be part of your grade. You can obtain a 12-month access to Achieve (and to the e-book version of the textbook) for about \$68 through a link to be provided by the publisher (available on Brightspace) If you prefer to have a hard copy of the book, the University's Bookstore also offers the book with access to the online Achieve platform.

Used books: A used textbook is also an option but please be aware that used books will most likely not include a valid/unused access code.

Achieve (online) Assignments: These are online assignments that will allow you to practice the concepts discussed in class. Preliminary deadlines are included in the platform and any changes will be

announced in class. You will have a week to complete each assignment. The assignments with the two lowest scores will be excluded from the final grade calculation.

Quiz: The date **will be announced at least a week in advance**. The quiz will take place during the scheduled lecture or tutorial times. If you miss the quiz for a documented compelling reason, the weight of the quiz will be reallocated to the final exam.

Written Assignment: The deadline for the written assignment will be announced at least one week in advance. No late assignments will be accepted. Use of ChatGPT and other generative AI is prohibited.

Missed course work: If you miss a mid-term examination or a significant number of tutorials/assignments for a documented compelling reason, you must submit a Self Declaration Form and the weight will be reallocated to the final exam. No makeup midterms will be offered.
