**Prerequisites for this course:** ECON 2102 with a grade of C- or higher, ECON 1001 with a grade of C- or higher, and ECON 1402 (or equivalent) with a grade of C- or higher. Precludes additional credit for ECON 2101.

Students who believe they have taken a similar background course or courses from another university must provide appropriate documentation to the Department of Economics Undergraduate Administrator, Sean Hall.

## **Course Description:**

This is the second of a sequence of two courses that aim at explaining the functioning of the aggregate economy. We will start with some of the models we developed in ECON 2102. We will extend them by focusing on the aggregate supply side of the economy. Using different models of aggregate supply, we will analyze macroeconomic problems and policy issues when prices and wages adjust gradually. We will compare the results we obtain in this setting with the results obtained in the very short run when prices are fixed as well as in the long run when prices adjust instantaneously. We will analyze the role of monetary and fiscal policy in this context. We will consider topics such as inflation, unemployment, and how policy can influence them. We will then turn to the microfoundations of macroeconomics and analyze in turn the consumption behaviour of households, the investment behaviour of firms as well as money supply and money demand. We will also consider some recent developments in macroeconomics. Please note that elementary mathematics will be used in this course.

## **Learning Outcomes:**

Learning about macroeconomic problems such as inflation and unemployment and how fiscal and monetary policy can influence them in a setting where prices adjust gradually. Both the closed and the open economy model will be considered.

*Midterm exam:* Students who miss the midterm exam for a valid reason (indicated to me by email as soon as possible) will have the associated weight added to that of the final exam. I reserve the right to request a Self-Declaration form or PMC letter of accommodation depending on the length of incapacitation. Special midterm exams will not be given.

*Final exam:* The final exam will be IN PERSON and will cover the entire course material, but more weight will be given to topics covered after the midterm exam. Special final exams will not be given.

Students are not to make travel plans during the exam period as that is not a valid reason for missing a final exam. Should the final exam be missed for any reason, a grade of F will be assigned, and the student must arrange for the possibility of a deferred examination through the Registrar's Office within 3 working days of the exam. If granted by the Registrar's Office, this exam will take place during the time designated in the Calendar for deferred exams. In the event that a student writes a deferred examination, the deferred examination will carry the same weight as the final examination in determining the course grade.

**Assignments:** Two assignments will be given to complement the lectures and will be marked for credit. It is **strongly recommended** that students do them carefully in order to improve their understanding of classroom material. Students will have about a week to complete the assignment and submit it. The use of Generative Artificial Intelligence tools (e.g. ChatGPT) to answer assignment questions is counterproductive. It has also been shown (by me) to lead to incorrect answers. In any event, it is considered to be plagiarism and is not permitted. Late assignments will not be graded, but provided the student has a valid reason (indicated to me by email), the weight of the assignment will be added to that of the final exam.

Standing in the course is determined by the course instructor subject to the approval of the Faculty Dean. This means that grades submitted by the instructor may be subject to revision. No grades are final until they have been approved by the Dean. (See Academic Regulation 2.3 for the official meanings of the grades and note that it stipulates that no course grades are final until approved by the Faculty Dean.)

#### Tutorials:

The tutorial period may be used for lectures, for tutoring by the TA, problem sessions, review sessions and going over answers to assignments. Tutorials will be given online, will be recorded, and the recording will be posted on Brightspace.

## Re-marking:

Any request for the remarking of exams must be submitted in writing within two weeks of that exam first being returned to the class. The request should contain a detailed explanation of why you feel you should receive a higher mark. Please note that remarking will apply to the entire exam not just the contentious question. As a result, the revised mark may be higher than, lower than or the same as the original mark.

# **Plagiarism**

Examples of sources from which the ideas, expressions of ideas or works of others may be drawn from include but are not limited to: books, articles, papers, literary compositions and phrases, performance compositions, chemical compounds, artworks, laboratory reports, research results, calculations and the results of calculations, diagrams, constructions, computer reports, computer code/software, material on the internet and/or conversations.

Examples of plagiarism include, but are not limited to:

- any submission prepared in whole or in part, by someone else, including the unauthorized use of generative AI tools (e.g., ChatGPT);
- using ideas or direct, verbatim quotations, paraphrased material, algorithms, formulae, scientific or mathematical concepts, or ideas without appropriate acknowledgment in any academic assignment;
- using another's data or research findings without appropriate acknowledgement;
- submitting a computer program developed in whole or in part by someone else, with or without modifications, as one's own; and
- failing to acknowledge sources through the use of proper citations when using another's work and/or failing to use quotations marks.

Plagiarism is a serious offence that cannot be resolved directly by the course's instructor. The Associate Dean of the Faculty conducts a rigorous investigation, including an interview with the student, when an instructor suspects a piece of work has been plagiarized.
