# 1 Overview/Objectives

This class offers a survey of Canadian history through an economic lens. The goal is to embed the Canadian experience within broader economic narratives and discussions examining why some countries see more economic success than others. In order to best achieve this, the first section of lectures will be devoted to an overview of methods of economic analysis which are required to make such institutional comparisons. Once the theoretical core of economic tools used in the class has been reviewed, we will move on to a topic-by-topic approach centering around historical Canadian experiences. See section 4 for more details on spesific class-by-class topics.

### 2 Class Format

Lectures will be live over Zoom during the scheduled lecture times. Students are strongly encouraged to keep there cameras on whenever possible. Understanding that the current pandemic is complicating our schedules and live attendance to all lectures may not be possible, recordings of each lecture will also be uploaded to Brightspace, however, students will still be graded on attendance and participation (see the student evaluation section of the syllabus below).

# 2.1 Brightspace

This course will make extensive use of Brightspace. On top of recorded lectures, materials such as lecture slides and the *Reading List*, as well as exam and paper information will be posted on Brightspace. Brightspace will also be used to send announcements to the class and will host discussion forums in which students can pose questions and comments related to the course.

### 3 Evaluation

Student performance in this course is evaluated as follows:

# 3.1 Attendance/Participation (10%)

Students are expected to be present for all Zoom lectures to the extent that it is possible. Furthermore students are expected to participate and actively engage with course material. Further details will be given during the first class.

# 3.2 Reading Reviews (30%)

Students are required to submit short (400-600 word) reviews for **three** of the required readings, worth 10% each. Which required readings are chosen for review are up to the discretion of the student, however, reading reviews must be submitted before 11:59pm on the day before the reading is discussed in class. Students may submit additional reading reviews in which case the grade will be determined by averaging your best three marks. Further details to be discussed in the first class and posted on Brightspace early in the semester.

# 3.3 In-class exams (30%)

There will be two multiple choice exams during the semester worth 15% each, each 1.5 hours in duration during the second half of the scheduled lecture time. The first is currently scheduled for Tuesday July 27th and the second for Tuesday August 10th. The midterm will be administered via Brightspace and exact coverage will be posted on Brightspace nearer the time. Students who can document a compelling reason for missing one of the exams will have the weight transferred to the other exam.

### 3.4 Term Paper (30%)

Students are required to write a term paper (of 2000-2500 words) as a final take home paper at the end of the semester, with the due date being the final day of the August 2021 exam period. Students will be provided a list of topics to write on and are expected to confirm with the instructor before the final class of the semester. The list of topics as well as more details on the paper requirements will be discussed during class and posted on Brightspace during the semester.

# 3.5 Plagiarism:

Please be aware that plagiarism is a serious offence in this course and at Carleton in general. All assigned writing projects are solo projects, therefore each student must submit independent and original work in order for your work to be considered for grading. Do not under any circumstance use the words or ideas of other authors without explicitly crediting them!
