Lectures: This is an **online** course. Approximately **half of the lecture time will be synchronous** (live with interactions between students and the instructor on Zoom) and the **remaining lecture time will be asynchronous** with pre-recorded lectures posted online. All lecture content will be posted online.

Prerequisites and Preclusions: Students should normally have completed ECON 1001 and ECON 1002 (or equivalent) and have a background in university level mathematics. The course is offered in support of the GDip in Economic Policy; however, other graduate students at Carleton University with adequate background may be admitted with permission of the Department of Economics.

Overview: How economic theory and empirical analysis are used to design and evaluate public policy, with emphasis on how the expectations, uncertainties, and practicalities faced by policymakers affect the design and implementation of economic policies.

Theoretical and empirical examples will be drawn primarily from **labour economics** with an emphasis on minimum wages, economics of education and immigration policy.

Evaluation:

There will be no in-person assessment.

- Assignments (40%): You will be required to submit two assignments during the semester. The first assignment will identify and describe an international migration policy of a particular country (maximum of 800 words). The country and policy are to be chosen by the student subject to the approval of the instructor. Each student in the class must work on a different policy/country combination. The second assignment will incorporate the instructor's feedback from the first assignment, and both propose and justify a beneficial change to this country's policy toward international migration (maximum of 1500 words).
- Presentations (20%): Each student will present their own policy papers (second assignment content) in the final 25% of the lectures. Presentations will be done during the lecture time using Zoom. Each student will have 15 minutes to present their findings and must have their cameras turned on throughout the presentation. During the presentation, the instructor and other students may ask questions.
- Final Exam (40%): The closed-book final exam will be written using Brightspace and the COMAS e-proctoring software in a 3-hour period and scheduled by Exam Services. Students will not be permitted to work together during the final exam. The final exam will be cumulative.

Missed Coursework: Students who can document a compelling reason for missing a midterm or an assignment will have the weight transferred to their final exam. Students who can document a compelling reason for missing more than two homework projects will also have the appropriate weight transferred to their final exam. In order to have the weight of a course component transferred to the final exam you must provide a <u>Self-declaration for Academic Accommodations Form</u>.

Academic Standing: Standing in a course is determined by the course instructor subject to the approval of the Faculty Dean. This means that grades submitted by the instructor may be subject to revision. No grades are final until they have been approved by the Dean.

Examples of plagiarism include, but are not limited to:

- any submission prepared in whole or in part, by someone else, including the unauthorized use of generative AI tools (e.g., ChatGPT);
- using ideas or direct, verbatim quotations, paraphrased material, algorithms, formulae, scientific
 or mathematical concepts, or ideas without appropriate acknowledgment in any academic
 assignment;
- using another's data or research findings without appropriate acknowledgement;
- submitting a computer program developed in whole or in part by someone else, with or without modifications, as one's own; and
- failing to acknowledge sources through the use of proper citations when using another's work and/or failing to use quotations marks.

Plagiarism is a serious offence that cannot be resolved directly by the course's instructor. The Associate Dean of the Faculty conducts a rigorous investigation, including an interview with the student, when an instructor suspects a piece of work has been plagiarized. Penalties are not trivial. They can include a final grade of "F" for the course.
