## SHAPE YOUR FUTURE BASED ON YOUR RESEARCH INTERESTS

The Department of Economics offers graduate programs of research and training leading to master's (M.Sc.) and doctoral (Ph.D.) degrees.

### M.Sc. in ECONOMICS

When you join us for an M.Sc. at Carleton you can choose among five different programs including our regular M.Sc. or specializations in either Financial Economics, Data Science, African Studies, or Climate Change. All our programs can be completed in one year, though if you need some extra preparation you can enter through our Extended M.Sc. requiring 2 years for completion.

A popular option among many students is our internship program that allows you to study part-time for one or two semesters while you complete a placement with a partner organization. These paid internships will give you valuable work experience and are a great way to transition into the workforce after graduation.

Our graduate placements in recent years speak to the quality of our program and success of our students. We have had students placed at the Bank of Canada, the Competition Bureau, Natural Resources Canada, Scotia Bank, Statistics Canada, Alterna Credit Union, Canada Mortgage and Housing Corporation, and Environment and Climate Change Canada, among others. Our M.Sc. also provides strong preparation for doctoral studies for students interested in continuing their graduate work. Many of our students have joined Ph.D. programs at top universities in Canada and abroad.

### PH.D. in ECONOMICS

The Ph.D. program is a joint program with the Economics Department at the University of Ottawa. The program provides students with the highest level of training and supervision from about 60 faculty members in both departments, making it one of the largest programs in North America. Our innovative coursework that emphasizes original research activities from an early stage of the program helps transition from a student to a researcher. Our faculty members, renowned for their research, are dedicated to supervising students. Many candidates present their work at top Canadian and international conferences and have academic presentations before graduation. ## ADMISSION REQUIREMENTS

The normal requirement for admission into our Ph.D. program is a master’s degree (or the equivalent) from a recognized university with an average of A- or higher.

The normal requirement for admission into our MA program is a B.A. (Honours) degree (or the equivalent) from a recognized university with an average grade of B+ or higher.

## REQUIRED DOCUMENTS

You need to provide the following documents:

- Two letters of reference
- Statement of Intent
- A copy of transcripts from all post-secondary institutions you have attended.
- If applicable, a copy of your English-language test results
- CV/Resumé
- GRE test results are not required. However, it is recommended that international students provide a GRE test result.

Note: Official documents (transcripts, test scores) will be required if you are accepted into our program.

## APPLICATIONS AND DEADLINES

The applicant deadline to be considered for Fall admission/funding is **February 1st**.

Note that there is no winter admission into the M.Sc. or Ph.D. program.

## LANGUAGE REQUIREMENTS

For admission into Carleton’s graduate programs, you will need to demonstrate that your knowledge and use of English are strong enough for graduate studies at an English-language university.
