Project Description:

The constructor's Notice of Project describes the project as:

-Dunton Tower Building Envelope Repairs/Restoration.

While on the project, the site superintendant stated the project involves creating control joints along 4 corners of the 30 storey building's brick. The control joints are being installed at the exterior elevations for the maintenance of the brick. Brick and mortar replacement are also in the scope of work. Two suspended work platforms are installed on the west elevation with one platform on the north.

The reason for this visit is to respond to a complaint made to the Ministry of Labour, Training, and Skills Development. The complaint alleges the following:

Workers are looking up at Dunton Tower located at Carleton University and concerned with falling debris.

Inspector's Findings:

September 24th 2020:

-Contacted Nancy Delcellier, Director of Environmental Health & Safety, by phone and advised her of the complaint. She mentioned that some restoration work was being completed at the exterior elevations of Dunton Tower. The employer stated that fencing was installed around the perimeter of the project.

-I later received a call from Jeremy Courtney, Bassi Health and Safety Officer confirming that perimeter fencing was installed around the project.

Accompanied by Ministry of Labour Inspector K.Munshaw, an inspection of the project was completed. The site superintendant stated that on September 23rd 2020 after completing control joints on the western elevation movement of the brick at the lower portion of the south/west wall was observed. Bassi stopped work pending further investigation by professional engineers.

IRC Building Sciences Group was employed to provide site conditions. The following is from a document produced by IRC Building Sciences Group and stated the following site instructions:

- i) Between the evening of Sept. 22 and the morning of Sept. 23, 2020 the south side of the west elevation experienced about 1/4" of movement downward in the main brick panel. IRC was informed and conducted a site review immediately upon notification.
- ii) Additionally, there is bowing of the brick of 1/4" to 1/2" in approximately 5' of the bottom 8' along the north side control joint of the panel.
- iii) Contractor has been instructed to halt further saw cutting of the control joints.
- iv) Contractor has been instructed to move the swing stage back to this elevation (south side of west elevation).
- v) Contractor has been instructed to open the masonry at the first shelf angle for IRC review. This is scheduled for review at 10:30am on Sept. 24, 2020. IRC will provide further instruction after this review.
- vi) IRC has reviewed the site condition and the client has been informed. Given that the brick is tied to the back-up structure with the original ties, which are in good shape, and the additional helical ties there is no immediate danger of the brick falling off of the building.

At the time of inspection, site instructions were being adhered to by Bassi and proper public way protections are in place.

After discussions with the constructor, a meeting was held with Carleton University Health and Safety Committee members. Discussions regarding the above findings were had and Ontario Regulation 213/91.
