Terms

The purpose of the Ontario Professional Engineers Foundation for Education Undergraduate Scholarships is to acknowledge the hard work of engineering students and promote the relevancy of becoming a licensed Professional Engineer (P.Eng.) in Ontario or elsewhere in Canada.

Eligibility and Selection Criteria:

To be eligible for an Ontario Professional Engineers Foundation for Education Undergraduate Scholarship applicants must be second, third, fourth or final year students enrolled in an engineering program in the Faculty of Engineering and Design at Carleton.

To be considered for a scholarship, eligible applicants must demonstrate at least one of the following:

- high engineering aptitude;
- leadership through participation in professional affairs;
- sustained participation in extra-curricular activities either on or off-campus; and
- continued volunteerism either on or off-campus.

When selecting recipients for this scholarship, particular consideration will be given to promoting equity and diversity within Carleton's Faculty of Engineering and Design. To this objective, a Voluntary Self-Declaration Form is available to be included with the scholarship application. Members of under-represented communities and groups in the Faculty of Engineering and Design's engineering programs are encouraged to apply.

Each award is valued at \$1,500 for the 2025-2026 academic year.

There are six awards to be allocated.
