# ENGL 3502 A British Literature II: A Study of Literary Cultures, 1700–1914

### COURSE DESCRIPTION:

This course is a survey of British literature from 1700 to 1914. In the years immediately prior to 1700, a court culture largely prevailed in Britain; by 1914, the country had long since been transformed into a modern democratic commercial society. Not surprisingly, the literature of that same period registers the concerns and anxieties, fears and hopes, of a variety of voices that lived through those remarkable changes. At the same time, the literature of the period undergoes a series of its own transformations as a result of the new pressures those changes exerted. In this course, we will explore a representative selection of authors from each literary period—the eighteenth century, the Romantic and Victorian eras, and the Modern period—whose writings give us access to some of the more significant literary, cultural, and socio-political developments of this 200-year block of British history.

This course is cuLearn supported. cuLearn is a virtual extension of the classroom, and you are expected to be familiar with everything circulated by its means. You should check our course page at least 2-3 times a week.

The Department of English has designated ENGL 3502 a "writing-attentive" course. That means that students in this course **must** 

- Write at least one substantial essay each term in which they are expected to
  - o develop an argument or thesis statement across each essay
  - o develop complex ideas using correct and effective expression according to academic English practice
  - o use and cite from primary texts appropriately
  - o develop secondary research and citation skills
- Complete at least two supervised writing assignments in the course (tests, in-class essays, or formal examinations)
- Spend a portion of class time developing and improving essay writing skills and research essay skills

## **LEARNING OUTCOMES:**

By the end of this course, successful students will have demonstrated their ability to:

- Create analytical readings of texts that are informed by the socio-political, cultural, and aesthetic developments of their authors' moment in history. This involves, for the texts studied, constructing readings that
  - o relate texts to contexts;
  - create linkages between developments in a period and authors' aesthetic and ideological expressions; and
  - demonstrate an awareness that literary texts intersect with real developments in their authors' society.
- Explain the core concerns, key debates, and landmark developments of each period under study, as well as points of convergence / divergence between them. This includes the ability, for each period, to explain in some depth
  - o significant generic innovations and literary developments;
  - o major historical, political, and cultural events;
  - o core concerns and ideological positions expressed by the authors; and
  - o relationships between the authors' ideological positions.
- Distinguish between the various literary terms explored in the course. This level of
  understanding entails the ability to
  - o define and explain those terms;
  - o identify relevant examples and use them to illustrate the meaning of those terms; and
  - o use those terms appropriately in analyses in the assigned papers and exams.
- Create effective research papers on literary topics that
  - develop arguments informed by, and which are situated in relation to, recent, relevant scholarship;
  - are clearly structured to advance their theses, using a thesis statement, a direction statement, topic and concluding sentences, and paragraphing that directly advances the argument;
  - engage closely with the words of the primary texts under study, unpacking those words to show how they advance a point being made;
  - engage closely with the arguments and words of the secondary texts, unpacking their words and arguments to show how they advance a point being made; and
  - o document all sources using proper MLA style (8<sup>th</sup> edition).

Hodges et al.'s *Harbrace College Handbook for Canadian Writers* [2<sup>nd</sup> floor reference, PE 1112. H37 1994]), and a dictionary of literary terms (J. A. Cuddon's *Dictionary of Literary Terms and Literary Theory* [2<sup>nd</sup> floor reference, PN 41. C83 1998]). Because these volumes are all designated "Library Use Only," they will <u>always</u> be available to you, free of charge.

#### **TEACHING APPROACH:**

I teach in a way that doesn't just invite your participation, but rather that demands it. In this class, you can expect me <u>not</u> to lecture at you in three-hour intervals. Instead, I will be giving mini-lectures interspersed by activities that require your involvement. These activities will provide you with opportunities to practice and develop the skills and content mastery announced in my learning outcomes, to measure the progress of your own learning, and to consolidate the knowledge and skills worked on in each class. Come prepared to be an active participant in your own learning.

### **COURSE POLICIES:**

**Attendance:** Regular attendance is vital to securing a passing grade in this course. More than 25% of your grade is determined by the work you do in class and/or in preparation for class

meetings. The exams, which cover materials taught in class, account for another 30% of your grade. In addition, I use an active learning approach, which means no amount of notes or consultation will capture the learning experience of the classroom. Commit now to regular attendance. If you need further motivation, note that if you miss three or more full classes in either term, I will award you with an "F" for the course, as per Section 2.1 of the Academic Regulations in the Undergraduate Calendar. Exceptions may be made, but only for students who can provide official documentation and/or who have demonstrated commitment to the course.

During each half of every one of our meetings, I will circulate a sign-in sheet. These sheets are the final authority on your attendance record. If you must leave class early or come in late, let me know in advance and you will get credit for that part of the class you attended—otherwise, failure to sign one of the sheets counts as an absence. Substantially late arrivals or early exits will be recorded. Every week or two, I will update the "Attendance Sheet" on cuLearn. It is your responsibility to keep up-to-date on this front.

Note: anyone who misses class is responsible for catching up with missed material. I'd strongly recommend reviewing the slides for the class missed, getting notes from a friend, and seeking me out during office hours, at which time I'll direct you to relevant sources. In every scenario involving your absence, be aware that you're responsible for taking initiative to make sure your grade doesn't suffer.

Basic Preparation: As a matter of course, you are expected to 1) attend all class meetings; 2) complete the scheduled readings beforehand and submit Notebook entries for at least 75% of those readings (with entries for longer texts being mandatory); 3) arrive prepared to discuss what you have read; 4) bring the relevant text(s) to class; 5) prepare and bring to class thesis/outline documents for Portfolio days; and 6) have a pen/pencil and piece of paper on hand in case of a Pop Quiz. I strongly recommend taking notes on the lectures and keeping a record of the passages and terms we discuss in class. Writing in the margins of your books and marking off key passages as you read is also a good idea. Passages and terms discussed in class are likely to appear on the Quizzes and Exams.

**Classroom Etiquette:** On the first day of class, we will discuss as a class expectations that we have for one another regarding what happens during class time. We'll establish an agreed upon list of classroom rules, to be posted on cuLearn, on the subjects such as the following:

- How do we feel about food and drink in the classroom?
- What will be our position on laptops and cell phones in the classroom?
- What constitutes respectful behaviour in this class and how will we promote it? What constitutes disrespectful behaviour and what will we do to discourage it?

Assignment Submission: All in-class assignments (the Pop Quizzes and the Exams) will be submitted in-class on their respective due dates. Most take-home assignments (the Essays and Portfolio Assignments 1, 2, and 4) will be submitted via cuLearn; note that cuLearn will automatically send you an acknowledgement email for all assignment submissions—if you don't receive that, then your assignment hasn't been submitted yet. By contrast, Portfolio Assignment 3 and 5 as well as all Notebook Assignment entries are to be submitted in class, in paper form, on the day in question. There is no other acceptable way to submit these.

Note: in the rare event that your assignment is lost, misplaced, or not received, you're responsible for having a backup copy that can be submitted immediately upon request. Note as well that it is your responsibility to make sure your file functions properly: a corrupted file or a file type that I can't open will <u>not</u> be grounds for a penalty-free extension. Submit your files in DOCX or DOC format.

**Extensions, Re-writes—The Token System:** Every student in this class begins with 5 tokens for the entire course (both terms). These cannot be subdivided into halves or any other increment. You can use tokens to gain penalty-free extensions for Portfolio assignments or the Essays or to submit a re-write for Essay #1, as follows:

- 1 token = a penalty-free 48-hour extension, relative to the original due date, on a Portfolio assignment or a Research Essay. Note, however, that tokens cannot be used in the exam periods: all assignments must be submitted by 11:59pm on June 20 (early summer term) and August 16 (late summer term).
- 2 tokens = submit a re-write of Research Essay #1. The re-write must be submitted 2 weeks after it was returned. Students can earn up to 25% extra on the original submission, up to a max of 100%, depending on the quality of the re-write—see the "Research Essay #1 Re-write" rubric for details on how these are evaluated.

If you want to use a token for an extension, no action is required; the number of 48-hour periods you use to complete the assignment after the original due date will automatically determine how many tokens you've used. To use tokens for a re-write of Essay #1, send me an email letting me know, and I'll follow up with instructions and a timeline for re-submission. I will track token usage, providing the class with updates every two weeks or so. Note that tokens can't be used for re-writes for any other assignment, and that they can't be used to extend the deadline for any assignment into the exam period in either term.

Unused tokens, by contrast, will translate into bonus marks (1% per) added to your overall course total. Use your tokens wisely, therefore, and be careful not to drain your reserve too early in the course.

**Late Assignments:** Students can use some or all of their tokens to earn extensions on some assignments (only the Portfolio assignments and the Essays)—see above. Note, however, that no assignment can be extended beyond 11:59pm midnight on June 20 (for early summer term work) or August 16 (for late summer term work). Once a student uses has run out of tokens, any Essay or Portfolio assignment s/he submits late receives <u>an automatic zero</u>. Similarly, there is no late policy for Quizzes, Notebook entries, or Exams: if these are not completed on time, you will earn a zero. Special consideration may be given to students dealing with a <u>protracted</u> medical issue for which they can provide documentation.

Completion of Course: Take careful note of Section 2.1 of the Academic Regulations in the Undergraduate Calendar: "To obtain credit in a course, students must meet all the course requirements for attendance, term work, and examinations as published in the course outline." If you have failed to complete any of the major assignments (the Portfolio assignments, the Research Essays, and the Exams) within the prescribed timelines, or if you have failed to comply with my attendance policy, you will fail the entire course.

**Email:** Use email <u>only</u> for quick questions, to set up alternate meeting times, or to handle personal issues (i.e., to advise me of a situation, etc.). If you want to discuss a paper (topic, thesis, outline, etc.), come to office hours. Email is not an effective means of dealing with such matters. There is not enough time before or after class, or during the break, to cover such issues adequately, either. Take advantage of office hours. I'm also available via BigBlueButton/Skype in some instances.

I answer emails Monday–Friday, 8:30am–4:30pm, but not outside of those times (i.e., weekday evenings and weekends). Be sure to provide a subject line and to limit yourself to the issues outlined above, and consult this syllabus to see if it answers your question before you send your email. Keep these simple guidelines in mind and you will find that I reply quite quickly (usually within 24 hours).

For questions your classmates might be interested in hearing the answers to (i.e., all questions about class content, assignments, and/or course policies), <u>please post them on the cuLearn "Ask</u> the Instructor" feature. That way, I can answer it once, for everyone.

**Telephone:** In general, avoid the phone altogether. I'm not in my office outside of announced times and have no voice messaging system. Stick to in-person and/or BigBlueButton/Skype interviews and email for all communication purposes.

**Grade Inquiries:** I'm always willing to review assignments. My one and only rule on this subject is *No discussions about grades until 48 hours after the assignment is returned.* That's because you need time to process my feedback and to be prepared to engage in a conversation with me about it. Once you've done so, come see me during office hours. Note that I'll be posting exemplary quizzes as I receive them, and that I'll be providing detailed feedback on the Portfolio assignments and Essays. Note, too, that requests for re-marking raise the possibility of a lower as well as a higher grade.

For the exams, students may arrange for a time to peruse them, but they can't remove, correct, or otherwise change them. They must remain, as is, with the department.

**Final Grades:** Standing in a course is determined by the course instructor subject to the approval of the Faculty Dean. This means that grades submitted by the instructor may be subject to revision. No grades are final until they have been approved by the Dean.

Course Copyright: My lectures and course materials (including all PowerPoint presentations, outlines, and similar materials) are protected by copyright. I am the exclusive owner of copyright and intellectual property of all course materials. You may take notes and make copies of course materials for your own educational use. You may not allow others to reproduce or distribute lecture notes and course materials publicly for commercial purposes without my express written consent.

**Academic Integrity:** The University Senate defines plagiarism as presenting, whether intentionally or not, the ideas, expression of ideas, or the work of others as one's own. Acts of academic fraud include the following:

- reproducing or paraphrasing portions of someone else's published or unpublished material, regardless of the source, and presenting these as one's own without proper citation or reference to the original source;
- submitting a take-home examination, essay, laboratory report or other assignment written, in whole or in part, by someone else;
- using ideas, quotations, or paraphrased material, concepts, or ideas without appropriate acknowledgement in an essay or assignment;
- failing to acknowledge sources through the use of proper citations when using another's work, and/or failing to use quotation marks;
- handing in substantially the same piece of work for academic credit more than once without prior written permission of the course instructor in which the submission occurs.

Plagiarism is a form of intellectual theft. It is a serious offence that can't be resolved directly with the course's instructor. The Associate Deans of the Faculty conduct a rigorous investigation, including an interview with the student, when an instructor suspects a piece of work has been plagiarized. Penalties are not trivial. They can include failure of the assignment, failure of the entire course, suspension from a program, suspension from the university, or even expulsion from the university.

It is <u>your</u> responsibility to know what constitutes academic fraud: for more information, see <u>Section 12</u> of the Academic Regulations described in the Undergraduate Calendar and Carleton's <u>Academic Integrity Policy.</u>

#### **ASSIGNMENT DETAILS:**

**Assignment Specifications:** Formatting instructions for individual Portfolio and Notebook Assignments will vary and will be provided for each; generally speaking, the specifications for these are less particular. Essays, however, must conform to the following specifications:

- Times New Roman, 12-point font; double spaced; one-inch margins (sides, top, and bottom); page numbers in the upper right corner; no extra spaces between paragraphs.
- A first page formatted according to MLA style, which means including the following pieces of information: the title of the essay (one that reflects the paper's contents/thesis, not just "Essay" or "Title of the Work I'm Writing On"), student name, course code and section, instructor's name, and date of submission.
- Proper documentation of sources (MLA style, 8<sup>th</sup> edition).

Note: failure to comply with assignments specifications will result in deductions of up to 10%. It is folly to throw away these marks. Format your assignments to request.

**Pop Quizzes** (10%; best 4 of 6, 2.5% per): The Pop Quizzes are designed to motivate you to attend classes regularly and do the reading(s), and to prepare you for the exams. There will be 6 Pop Quizzes in total; your best 4 will account for 10% of your mark. If you miss a class when a Pop Quiz is given, you forfeit the opportunity to earn those marks. Documentation to explain your absence will keep you from losing marks, but under no circumstances will you be allowed to write a "make-up" Pop Quiz, since that would defeat the purpose of the exercise.

The Pop Quizzes will be administered on random days and times. You will be given two passages from a work or works that we have recently read. For the passage of your choice, you will have 15 minutes to

- correctly **identify** the author and the title of the work (1 mark), and the work's formal and generic properties (1 mark):
- unpack/explain and elaborate on what is being said in the passage/lines and how it/they
  relate to the larger work (2 marks); and
- **interpret** the passage by, for example, situating the passage and/or text in dialogue with the larger cultural, sociopolitical, and historical contexts discussed in class (2 marks).

Notebook Assignment (15%; min. of 12 or 13 entries per term, 7.5% per term): The Notebook Assignment requires you to create notes for each of our assigned readings, using the appropriate template from cuLearn for each reading. I will provide feedback on your first two entries, to guide expectations, but what I assess in the end is the final product—that is, your collection of notes at the end of each term. The minimum requirement for your Notebook is entries for ~75% of our readings—i.e., 12 of our 16 readings in the first term and 13 of our 18 readings in the second term (I'll ask for 2 entries on Tennyson's long poem), with entries for all long texts (Swift, Mackenzie, Scott, Byron, Tennyson x2, and Conrad) being mandatory.

#### Each entry

- is due, in *paper* form, at the *start of class* on the *first day* we are scheduled to discuss the text in question—no exceptions and no alternate submission formats. See the assignment description for the full schedule.
- must be formatted as requested (single spaced, 12-point Times New Roman font, minimal white space) and meet minimum requirements for length
- must follow the appropriate template (introduction, contexts, poem, novel, prose, play, other)
- must be as thorough and accurate as possible, and demonstrate a good faith effort to
  document your engagement with the text as you read

\*NOTE: how well one does in the Notebook Assignment is largely a function of time-on-task and effort. This course will reward both, as well as improvement. Accordingly, students who score 80% (12 out of 15) or higher on this assignment will have the right (if they choose) to shift half (7.5%) of the weight of the Midterm Exam to the Final Exam.

Writing Portfolio (15%; 5 assignments, 1-4% per): There are  $\underline{5}$  assignments in total, each worth 1-4%, as follows:

- An Online Quiz (1%): the quiz is located here. Once you successfully complete the quiz, you will earn a certificate. Save that certificate as a PDF and then submit it via the online submission form for 1%. The certificate is due May 15<sup>th</sup>.
- 2. <u>MLA Exercise (4%)</u>: you will research a literary topic (i.e., the subject of your first Essay), looking for 12 recent and relevant sources. You will then create a Works Cited that follows the latest MLA guidelines, for 4%. This assignment is due May 22<sup>nd</sup>.

- 3. Two Peer Reviews (4% x 2): approximately 2 weeks in advance of each Research Essay, you will take part in a 3-step peer review exercise. Worth 4% a piece, these will take place during the weeks of May 27<sup>th</sup>/29<sup>th</sup> and July 22<sup>nd</sup>/24<sup>th</sup>
  - a. Step 1: Create an outline for your upcoming Essay using a template provided (before May 27 & July 22<sup>nd</sup>)
  - Step 2: Come to class, exchange outlines with an assigned peer, and review each other's work using a rubric provided, providing written and oral feedback (on May 27<sup>th</sup> & July 22<sup>nd</sup>);
  - c. Step 3: Go home, reflect on your partner's feedback, and produce a reflective document using the template provided. This piece should be 1.5~ pages long if single spaced, 3~ pages long if double spaced (due on May 29<sup>th</sup> & July 24<sup>th</sup>); and
  - d. Step 4: On the due dates (May 29<sup>th</sup> & July 24<sup>th</sup>), hand in all three documents (the original outline, your partner's feedback form, and your reflection piece), stapled together in that order, with your and your partner's name prominently displayed on page 1.

Note: to earn grades for this exercise, you must come to class with an outline and participate in the in-class peer review and work with a different partner each time. If you don't participate in the in-class peer review exercise, you forfeit the 4%. If you can provide advanced notice that you'll be absent the day of the peer review, we can make alternate arrangements for you; if you can provide documentation to explain an absence that emerged at the last moment, we'll work something out.

4. <u>A Reflection Piece (2%)</u>: you will write a reflection piece in which you reflect on the feedback provided on Research Essay #1 and, more generally, the experience of writing that essay. This assignment is due July 10<sup>th</sup>. A rubric will be provided on cuLearn—review it carefully before submitting your reflection via cuLearn.

\*NOTE: how well one does in the Portfolio Assignments is largely a function of time-on-task and effort. This course will reward both, as well as improvement. Accordingly, students who score 80% or more (12 out of 15), collectively, on these 5 assignments will have the right (if they choose) to shift half (7.5%) of the weight of Research Essay #1 to Research Essay #2.

Research Essay #1 & 2 (15% & 15%): Each of your research essays will be 3,000 words (9–10 pages) long and are due on Friday, June 14<sup>th</sup> and Friday, August 9<sup>th</sup>. Topics and marking rubrics will be available on cuLearn well in advance of these deadlines. Note that papers submitted on a topic that I haven't set or vetted and approved of explicitly via email will not be graded. Students who score 80% or higher on the Portfolio Assignments can choose to re-distribute 50% of the weight of Research Essay #1 to Research Essay #2 (i.e., Essay #1's weight is reduced to 7.5% while Essay #2's weight increases to 22.5% of the course grade).

Exams #1 & #2 (15% & 15%): The Exams are designed to test you on the lecture and reading materials for each term (non-cumulative). You can expect a Midterm and Final Exam with three parts. Part 1 will require you to define literary terms and illustrate their meaning using a text we have discussed in class; Part 2 will require you to identify passages from the assigned readings, list their formal and generic properties, elaborate on their meaning, and situate the passage in dialogue with the larger text and issues in the period; and Part 3 will require you to write an argumentative essay in which you will need to analyze a number of texts in relationship to one another and/or some specific context. All exams will be based on material covered in the lectures

and the assigned readings. Students who score 80% or higher on the Notebook Assignment can choose to re-distribute 50% of the weight of Exam #1 to Exam #2 (i.e., Exam #1's weight is reduced to 7.5% while Exam #2's weight increases to 22.5% of the course grade).

Note: the dates for Early Summer (June  $21^{st}$ – $27^{th}$ ) and Late Summer (Aug.  $17^{th}$ – $23^{th}$ ) Exams are set by the University. Absence from exams will only be excused in the event of serious extenuating circumstances for which you can provide documentation (such as accident, illness, bereavement, or religious accommodation). To secure a Deferral, you must submit supporting documentation in a timely fashion. Travel for business or pleasure is not considered a valid reason for failure to attend an exam. To that end, do not make travel plans for the exam periods until the dates of all your exams are known.
