Topic: Migrancy, Hybridity, and the Politics of Home in South Asian Diaspora Literature

Course description: This seminar focuses on the literature that has arisen out of colonial experience and decolonization, specifically concentrating on forms of dislocation and displacement as experienced by and expressed in the writings of the postcolonial authors belonging to the South Asian diaspora. The course explores texts that narrate the experiences of transnational mobility including exile and forced migration. We shall study a variety of genres including poetry, fiction, and graphic narratives written by established as well as emerging contemporary authors. The readings will also include pieces that theorise the South Asian migrant experience, especially related to the questions of home and identity, the intersection of gender and caste, and the affective dimensions of migration and diaspora.

### II. Course Format/Mode of Delivery

The course will be offered in the blended format, i.e., it will be taught as a blend or combination of synchronous live meetings and asynchronous activities. For the synchronous part of the course, the students will require reliable high-speed internet access and a computer with microphone (and ideally a webcam). A headset would be very useful too.

The asynchronous activities will take place on the course page on Brightspace, which would be the figurative home for this course and you will be able to access it a few days before the first week of classes. This page will contain course lectures, videos, announcements, links to shorter readings, as well as platforms to submit your assignments, post discussion entries, take quizzes etc. So, it is absolutely imperative that you access the course page regularly to succeed in this course!

#### What is a Blended Course?

An online course where there is a mixture of synchronous meetings and asynchronous activities. This means students need to be prepared to meet some of the time online via web conferencing tools at scheduled days and times. The specific dates will be communicated by the instructor in the course outline. The asynchronous activities are intended to provide flexibility to students when the class is not meeting synchronously. Students are expected to remain up to date with the deadlines and due dates provided by the instructor. These courses require reliable high-speed Internet access and a computer (ideally with a webcam), and a headset with a microphone.

#### **III. Learning Outcomes:**

After completing this course, the students will be able to:

- Engage with and discuss concepts and issues like migrancy, indigeneity, home, and belonging in diaspora literature
- b) Analyze the relationship of territory to creative imagination and the formation of complex identities problematized by the tension between the colonial past and the postcolonial present.
- c) Investigate the categories of religion, ethnicity, caste, and gender, and their implications in the everyday life of the South Asian diaspora.
- d) Identify and discuss the correlation between the postcolonial predicament and experiences of migrancy.

well as read a selection of essays. The shorter readings (essays and poems) as well as the movies will be available on Brightspace (through ARES).

#### VI. Evaluation:

#### **Discussion Forum Posts: 50%**

The students will write discussion posts on the weekly readings, on Brightspace discussion forums. Prompts or guiding questions, along with instructions and a rubric of evaluation will be provided. There will be **eight discussion forums** throughout the term (the weeks are identified in the schedule below).

### Final Project Proposal + Annotated Bibliography 10%

The proposal for the final project should be about one page long (Times New Roman, Font size 12) and the Annotated Bibliography (4-5 secondary sources) should follow MLA guidelines. Instructions and samples will be provided on Brightspace.

### Final Project: 30%

For the final project, you will have the option of either <u>writing an essay</u> (8-10 pages; font size 12, double spaced) <u>or doing an individual presentation over Zoom</u> (15-20 mins + Q/A using Powerpoint/Prezi). Both options (essay or presentation) would require in-depth research and analysis. The presentation slides and script need to be submitted. You must have a substantial thesis statement/argument and demonstrate the use of secondary sources which need to be seamlessly and effectively woven into your analysis. You would need to specify your choice (essay or presentation) by February 15.

### Virtual Engagement: 10%

Throughout the term, the students are expected to actively participate in the guided discussions and other activities on Brightspace and during the live synchronous sessions. In addition, there will be feedback forms and optional activities on Brightspace, the completion of which would go towards the mark for this component.

Please note that the standing in a course is determined by the course instructor subject to the approval of the Faculty Dean. This means that grades submitted by the instructor may be subject to revision. No grades are final until they have been approved by the Dean.
