I. Course description:

The theatre director and dramaturge are largely twentieth-century constructs that have become prevalent in contemporary theatre creation. This course will give students the opportunity to explore the director's craft; from extensive research related to the play to practical decisions of how to rehearse and prepare a piece of theatre for performance in collaboration with designers and composers. Students will create a Director's Concept and stage a selected scene from Caryl Churchill's play *Love and Information*. Dramaturgy will be examined as part of the director's preparation in developing a concept prior to the rehearsal process. Students will have the unique experience of collaborating with design students from the Azrieli School of Architecture and Urbanism under the teaching of Professor Yvan Cazabon as well as with Carleton Music students studying composition with Professor Jesse Stewart. Scenes will be presented for an audience at the end of term. Attendance of all lectures/workshops is required. Some rehearsal time outside of scheduled class time will be necessary.

Course Objective

Students will leave this course with an appreciation for the director's roles as interpreter, creator, coach and collaborator through the practical experience of staging a piece of theatre. *Process* will be the central focus, allowing each student to devise a unique approach to creative leadership based on historical and contemporary models of theatre practice.

<u>Note:</u> Canadian Director Robert Lepage will be visiting Carleton for a discussion of his production, 887, playing at the National Arts Centre, on January 12th in the Discovery Centre of the MacOdrum Library, room 482, 2 - 4 p.m. **Students are required to attend.**
