- **I. Course description**: The writers from the South-Asian subcontinent have produced one of the richest bodies of literature in English in recent times and have made significant impact on contemporary literary studies. This course introduces students to representative literature from India, Pakistan, Bangladesh, Sri Lanka, and Nepal. Some of the issues that we shall focus on include the history of colonialism and decolonization (Independence/Partition) of the subcontinent, the role of English education and the formation of a distinct postcolonial cultural consciousness, social dynamics of caste and gender, issues of migration, globalization, and social change. We shall read representative works novels, short stories, and poetry by authors who live in and write from South Asia as well as those belonging to the South Asian diaspora.
- III. Learning Outcomes: After the completion of this course, the students will be able to:
- i) critically engage with South Asian literary texts and situate them in the relevant historical and political contexts.
- ii) assess and compare literary traditions, strategies, devices, and tropes in South Asian literature.

- iii) investigate and analyze South Asian literary texts through relevant theoretical lens, including postcolonial, feminist, diaspora, and anti-caste theories.
- iv) develop critical thinking and writing skills through discussions and writing activities throughout the term.

# V. Evaluation:

## Discussion Forum Posts (7): 35%

The students will write discussion posts on the weekly readings, on Brightspace discussion forums. Prompts or guiding questions, along with instructions, expectations, and rubric of evaluation will be provided. There will be eight discussion forums throughout the term and the best seven would be counted (the weeks are identified in the schedule below). The posts will be due by Friday, 10 pm.

## Reflective Blog Entries (2): 20%

Each entry should be about 500 words long and should reflect critical and analytical engagement with a specific aspect of the text (a theme, character, context etc.). They are not research papers and will not require secondary research. A blog entry may be developed into a research question for the final essay. Detailed instructions and a rubric of evaluation will be provided on Brightspace. (**Due on February 9 and March 9**)

## Participation and Engagement: 15%

Throughout the term, the students are expected to actively participate in the guided discussions and other individual and group activities in class. Students will be graded in terms of preparedness for the class as well as the level of participation in class discussions. In addition, there will be feedback forms, self-assessment exercises, as well as optional activities on Brightspace.

## Final Essay: 30%

The final essay (8-10) pages, font size 12, double spaced) would require in-depth research and analysis. You must have a substantial thesis statement/argument and demonstrate the use of critical secondary material. Detailed instructions and a rubric of evaluation will be provided on Brightspace. (**Due on April 11**)

Please note that the standing in a course is determined by the course instructor subject to the approval of the Faculty Dean. This means that grades submitted by the instructor may be subject to revision. No grades are final until they have been approved by the Dean.

- using another's data or research findings without appropriate acknowledgement;
- submitting a computer program developed in whole or in part by someone else, with or without modifications, as one's own; and
- failing to acknowledge sources through the use of proper citations when using another's work and/or failing to use quotations marks.

Plagiarism is a serious offence that cannot be resolved directly by the course's instructor. The Associate Dean of the Faculty conducts a rigorous investigation, including an interview with the student, when an instructor suspects a piece of work has been plagiarized. Penalties are not trivial. They can include a final grade of "F" for the course.
