COURSE DESCRIPTION: This course is designed to introduce students to the basic tools of written language use in English, engaging with language from a model that explores how meaning is built by the performance of sounds and words in codified ways. Taking our cue from the textbook's structuring principle, we will consider the form, function and position of words in sentences and the varieties of each element that are available for sense-making. Along the way, we will define integral premises of language creation and use like morphology (word forms), syntax (word placement), and semantics (word/idea meanings), as well as considering questions of "grammatical correctness" and problems of usage. Generally speaking, then, our approach will be descriptive rather than prescriptive, that is, we will come to the study of English on the basis not of standards and deviations but of a cumulative understanding of linguistic performance—how our language works to build and express ideas. Such an approach expects a prior knowledge of English sufficient to be able to discuss its semantic constructs; this is therefore not an ELS course, nor will it serve students as a stand-in for such.

- 3) Posted Grades: All assignment grades will be posted on the course's cuLearn site. Standing in a course is determined by the course instructor subject to the approval of the Faculty Dean. This means

that grades submitted by the instructor may be subject to revision. No grades are final until they have been approved by the Dean.

4) Plagiarism: The University Senate defines plagiarism as "presenting, whether intentionally or not, the ideas, expression of ideas or work of others as one's own." This can include:
□ reproducing or paraphrasing portions of someone else's published or unpublished material, regardless of the source, and presenting these as one's own without proper citation or reference to the original source;
□ submitting a take-home examination, essay, laboratory report or other assignment written, in whole or in part, by someone else;
□ using ideas or direct, verbatim quotations, or paraphrased material, concepts, or ideas without appropriate acknowledgment in any academic assignment;
□ using another's data or research findings;
☐ failing to acknowledge sources through the use of proper citations when using another's works and/or failing to use quotation marks;
□ handing in "substantially the same piece of work for academic credit more than once without prior written permission of the course instructor in which the submission occurs."
Plagiarism is a serious offence that cannot be resolved directly by the course's instructor. The Associate Dean of the Faculty conducts a rigorous investigation, including an interview with the student, when an instructor suspects a piece of work has been plagiarized. Penalties are not trivial. They can include a final grade of "F" for the course.

- 5) **Preparation & Attendance:** While attendance will not be actively monitored, regular attendance at lectures is expected. Lecture notes or synopses will not be provided to students missing class—it is your responsibility to make up for missed work. Active participation is expected; this means being prepared to take notes, discuss readings and assist in completing sample exercises.
- 6) Communication: I will use email and the cuLearn course site to communicate with students; you are advised to check both regularly. You are encouraged to contact me through email using your connect accounts. Please indicate your concern in the subject line (e.g. "pronoun question"); unidentified emails will be deleted. Excessive informality is discouraged. I check email at least once daily Monday to Friday (usually sometime in the morning) but RARELY on weekends. This means last-minute emails concerning assignments or what-have-you will likely not be returned in time to clarify questions (particularly those sent later in the day on Fridays).
- 7) Classroom Etiquette: Students are expected to be on time for each class so as not to disrupt the lecture for other class members. Also any electronic activity is expected to be for note-taking purposes only; texting, surfing, "facebooking," "tweeting" etc are rude and disruptive for all others in the classroom.
