**ENGL 1020D: Effective Writing Preclusions:** ENGL 1010

**I.** Course description: This course will introduce students to the fundamental skills employed in writing at an undergraduate university level, focusing on such areas as rhetoric, research, persuasion and critique. Additionally, this course will be a multimedia delivery, involving a weekly schedule involving material to watch, read, listen, and then respond in writing. Students will be expected to write consistently over the course. It is better to learn to write by writing than it is to listen to me talk about writing. As such, I will be giving consistent feedback on short writing assignments in addition to lectures. We will explore various essay formats, including online video and traditional essays, in order to understand the composition and style necessary to examine, understand, and produce our own essays.

While lectures, materials, and assignments will be posted in advance asynchronously, students are welcome to stop by throughout the week in virtual office hours, where I will offer advice and assistance for students.

**II. Preclusions:** This course precludes additional credit for ENGL 1010

**III. Learning Outcomes:** Through an approach that blends practice with analysis, students will learn the steps of essay construction from topic choice to final revision. The lectures and assignments will be divided among theoretical discussions of writing principles, workshops to implement these ideas and improve students' grammar and writing skills, and the examination of short essay pieces to develop analytic skills.

**IV. Texts:** Course materials and texts will be posted on Brightspace and available on Ares through the Library.

#### V. Course calendar:

Week 2: Thesis and argumentation. Writing exercise due.

Week 3: Types of essays, logic and consistency.

- Week 4: Introductions, Conclusions. Writing exercise due.
- Week 5: Outlines, Drafts. Short essay due
- Week 6: Common Grammar Errors. Writing exercise due
- Week 7: Research skills. Writing Exercise due
- Week 8: Integrating and managing evidence. Writing exercise due
- Week 9: Quotation, documentation, general errors.
- Week 10: Effective style and tone.
- Week 11: Revision and Editing.
- Week 12: Media specific considerations. Research Paper due
- Week 13: Exam essay writing style and practice.

Additionally, we will be reading several essays (posted on Brightspace and available through Ares) that will inform our writing exercises and essays.

### **VI.** Evaluation:

Writing Response Workshops: 20%

Short Essay: 20% Research Essay: 30% Final Essay 30%

# VII. Statement on Plagiarism

- using ideas or direct, verbatim quotations, or paraphrased material, concepts or ideas without appropriate acknowledgment in any academic assignment;

- failing to acknowledge sources through the use of proper citations when using another's works and/or failing to use quotation marks;
- handing in substantially the same piece of work for academic credit more than once without prior written permission of the course instructor in which the submission occurs.

Plagiarism is a form of intellectual theft. It is a serious offence that cannot be resolved directly with the course's instructor. The Associate Deans of the Faculty conduct a rigorous investigation, including an interview with the student, when an instructor suspects a piece of work has been plagiarized. Penalties are not trivial. They can include failure of the assignment, failure of the entire course, or suspension from a program.
