Standards under the Accessibility for Ontarians with Disabilities Act

# Background

Businesses and organizations which provide goods and services to people in Ontario (including Carleton University) will have to meet certain new accessibility standards, embedded in provincial regulations of the *Accessibility for Ontarians with Disabilities Act* in the following five areas: Customer Service; Information and Communications; Built Environment; Employment and Transportation.

Ontario's first accessibility standard, Customer Service, came into effect on January 1, 2008 and compliance was required by December 2009. The other standards were implemented over three years (estimated), until 2012

# <u>Task Force - Terms of Reference</u>

#### Mandate:

- To ensure co-ordinated communication with the Ministry of Community and Social Services and other interested parties (e.g. Council of Ontario Universities) on all matters relating to the new standards (e.g. Feedback on the new standards)

- To identify, budget for, and assign university-wide human and financial resources as required
- To monitor university compliance with the new standards
